(c) Roads and wells are being provided in the area allotted for rehabilitation at Company's cost.

The Company is selecting persons who have a certain educational qualification, from among the persons to be evicted, for training them to take up jobs in the Cochin Fertilizer Project.

Permission has been given to the owners to take the structures in the acquired land costing less than Rs. 1.000 free of cost.

Judgement in Espionage Case

- 894. Shri Utiya: Will the Minister of Home Affairs be pleased to state:
- (a) whether the Government's attention has been drawn to the judgement delivered by the Presidency Magistrate, Calcutta in the Azizul Islam espionage case;
- (b) whether it is a fact that there is no law under which espionage cases can be prosecuted and conviction obtained in peace time and/or/when there is no emergency; and
- (c) if so, whether Government have under consideration a proposal to introduce legislation making espionage offences punishable with imprisonment and fine?

The Deputy Minister in the Ministry of Home Affairs (Shri Vidya Charan Shukla): (a) Yes, Sir.

(b) and (c). The Indian Official Secrets Act, 1923 provides for prosecution of persons involved in espionage cases even in peace time. It is proposed to make the existing provisions of the Act more effective and an amending Bill has been introduced in the Lok Sabha for this purpose.

Inland Letters

895. Shrimati Ramdulari Sinha: Will the Minister of Communications be pleased to state:

 (a) whether it is a fact that inland letters are not available in most of the Post Offices of Patna and muffasil for several days;

- (b) whether it is also a fact that in Mahendrughat Post Office of Patna, there was a dearth of inland letters for several days in the second week of October;
 - (c) if so, the reasons therefor; and
- (d) whether Government are aware that such scarcity has resulted in black-marketing of inland letters?

The Minister of State in the Departments of Parliamentary Affairs and Communications (Shri Jaganatha Rao): (a) There had been some shortages of Inland Letter Cards in post Offices under Patra H.O. in the first fortnight of October, 1966.

- (b) There is no post office by the name of Mahendrughat. There was however shortage of Inland Letter Cards in the first fortnight of October 1966 at Mahendru Sub Post Office under Patna H.O.
- (c) Due to lack of printing capacity there had been inadequate supply of Inland Letter Cards from the Controller of Stamps, Nasik Road.
- (d) No such information is available with the Department. However necessary foreign exchange has been released and orders for additional printing equipment have been placed for augmenting the capacity for printing of Inland Letter Cards at the Security Press, Nasik.
