- (c) if the reply to parts (a) and (b) above be in the affirmative, the reasons thereof?

New Companies in Publishing Field in Delhi

- 6363. Shri Sardar Amjad Ali : Will the Minister of Industrial Development, Internal Trade and Company Affairs be pleased to state :
- (a) how many new companies in the publishing field commenced business in Delhi between October, 1968 and March, 1970;
- (b) the names and addresses of registered and head offices and also of Directors of those Companies;
- (c) which of these companies or their Directors and Promoters have entered into collaborational contract with American publishers and foreign individuals; and
- (d) whether all these companies maintain sign plates outside their premises ?

The Minister of Industrial Development, Internal Trade and Company Affairs (Snri F. A. Ánmed): (a) and (b). During the period October, 1968 to March, 1970, 14 such companies, limited by shares, were registered in Delhi. The particulars relating to their names, dates of registration, addresses of registered offices and the names of their directors are given in the statement laid on the Table of the House. (c) According to the available information Messrs Amerind Publishing Co. (Private), Ltd., New Delhi had entered into collaboration with foreign publishers viz., Amerind Publishing Corporation, New York.

(d) Every company registered under the Companies Act is required in terms of the provisions of Section 147(1) (a) of the Act to paint or affix its name and the address of its registered office outside the office or place in which its business fs carried on.

DIESELISATION OF KANGRA VALLEY AND KALKA-SIMLA SEC-TIONS OF NORTHERN RAILWAY

6364. Shri Hem Raj: Will the Minister of Railways be pleased to state:

- (a) whether it is a fact that the Committee on Uneconomic Railway Lines has recommended for the dieselisation of the narrow-guage Kangra Valley section and Kalka-Simla Section of the Northern Railway;
- (b) whether it is also a fact that some years ago a few engines were ordered for the Kangra Valley section; and
- (c) if so, what has become of them and the time by which these narrow-gauge sections would be dieselised?

The Minister of Railways (Shri Nanda): (a) Yes. Kalka-Simla Section is already partially dieselised.

(b) and (c). 25 Narrow Gauge Diesel Locos were procured in 1964-65 for Indian Railways and these were allotted as under:

> Northern .. 10 South-Eastern .. 15

10 Narrow Gauge Diesel Locos are proposed to be manufactured during the 4th Plan. Dieselisation of various sections keeping in view the recommendations of the Uneconomic Branch Lines Committee 1969 will be kept in view as these locomotives become available.

EXTENSION OF MADRAS JANTA EXPRESS TRAIN TO PATHANKOT

6365. Shri Hem Raj: Will the Minister of Railways be pleased to state:

(a) whether it is a fact that the Srinagar

Express and Kashmir Mail go overcrowded throughout the year;

- (b) whether it is also a fact that the Calcutta (Eastern Region) and Bombay (Western Region) people are served by the Sealdah Express and Paschim Express respectively;
- (c) whether it is further a fact that the Southern States have got no train for Pathankot, and the military personnel and the tourists from that area are put to great difficulty; and
- (d) if so, whether Government propose to extend the Madras Janta Express to Pathankot for the convenience of passengers from the South and ease overcrowding for Pathankot at Delhi?

The Minister of Railways (Shri Nanda): (a) Yes. Mostly on the stretch between Ambala and Pathankot.

- (b) Calcutta and Pathankot are linked by a direct train viz. Sealdah-Pathankot Expresses but there is no direct train between Bombay and Pathankot althogh 3 through coaches are provided during the period from April 1 to November, 15 between these points by Frontier Mail which connects the Kashmir Mail at Delhi. Paschim Express runs between Bombay Central and New Delhi/Amritsar
- (c) and (d). There is no direct train linking Pathankot with the Southern States. Suitable connecting services are however, available with a change at Delhi/New Delhi during convenient hours. No 60 leaves Pathankot at 22.50 arrives New Delhi at 9.55 and connects No. 18 which leaves New Delhi at 10.50. In the other direction no. 15 arrives New Delhi at 11.10 and connects No. 59 at 21.10. The extension of 17 Dn./18UP Madras-Delhi Janta Express to and from Pathankot is therefore neither considered necessary not it is feasible at present for want of line capacity, particularly in Delhi-Ambala section.
