## Creation of Jharkhand State

4016. SHRI N. E. HORO: Will the Minister of HOME AFFAIRS be pleased to state :

- (a) whether Government intend to fulfil the aspirations of the people of Chhotanagpur Plateau and its contiguous areas by agreeing to create a separate Jharkhand State; and
- (b) if so, the action Government intend to take ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND MINISTER OF STATE, DEPARTMENTS OF ELECTRONICS AND SCIENTIFIC AND INDUSTRIAL RESEARCH (SHRI K. C. PANT): (a) and (b). The question whether Jharkhand should be a separate State or should form part of Bihar was considered by the States Reorganisation Commission in 1955 and the Commission came to the conclusion that there was no justification for the creation of a separate Jharkhand State. The Government of India agreed with this recommendation of the Commission. There is no intention to reopen this issue.

It has also been selected as an industrially backward district and as such industries to be set up in the district will be getting certain financial concessions from financial institutions. The Central Government will also give subsidy to the extent of 10% for approved industrial projects to be set up in the district.
