The Lok Sabha met at Eleven of the Clock.

OBITUARY REFERENCES

MR. SPEAKER: I have to inform the House of the said demise of Dr. Saradish Roy, a sitting Member and Shri Ram Narain Sharma, a former Member of Lok Sabha.

Dr. Saradish Roy was elected to the Lok Sabha in the last general elections from Bolpur Constituency of West Bengal. He had also been a Member of Third, Fifth, Sixth and Seventh Lok Sabha during 1962-67 and 1971-84 respectively. A Medical practitioner by profession, Dr. Roy took special interest for the welfare of the working class. He was associated with the Indian Medical Association.

An able parliamentarian, he took been interest in the proceedings of the House. He was the leader of his group in Lok Sabha. Dr. Roy served on the Business Advisory Committee and other Parliamentary Committees.

Dr. Saradish Roy passed away on 5th May, 1985 at New Delhi at the age of 67 years.

Shri Ram Narain Sharma was a Member of the Fifth Lok Sabha during 1971-77 representing Dhanbad constituency of Bihar. Earlier, he had been a Member of the Bihar Legislative Assembly for 16 years during 1952-68.

A veteran freedom fighter, Shri Sharma took active part in the freedom struggle and suffered imprisonment for several years.

A well known trade unionist and social worker, Shri Sharma was associated with

several trade unions and social organisations. He worked relentlessly for the welfare of the working class and forcefully represented their cause both inside and outside the Parliament.

A widely travelled person, he attended the meeting of the International Labour Organisation's Coal Committee and the Annual Conference of the International Miners Federation in Stockholm in 1960.

Shri Ram Narain Sharma passed away on 11 April, 1985 at Dhanbad at the age of 70 years.

We deeply mourn the loss of these friends and I am sure the House will join me in conveying our condolences to the bereaved families.
