(a) the details of the number of City Gas Distribution (CGD) projects set up in Andhra Pradesh during the last five years;

(b)the list of the companies that have taken up the said projects;

(c) the progress made on these projects along with the timeline set for its completion;

(d) the quantum of funds disbursed thereon, year-wise;

(e) whether any new project proposals have been received for setting up CGD pipeline; and

(f)if so, the details thereof and if not, the reasons therefor?

(a) to (f) Providing Piped Natural Gas (PNG) connections and establishment of Compressed Natural Gas (CNG) stations, are part of development of City Gas Distribution (CGD) network and the same is carried out by the entities authorized by the Petroleum and Natural Gas Regulatory Board (PNGRB). After completion of 12/12A CGD bidding round, the entire state of Andhra Pradesh has been covered under CGD network. The project cost for CGD projects are borne by the concerned CGD entities as per their Minimum Work Plan and techno-commercial feasibility. The authorized entities (including one Geographical Area spread over Andhra Pradesh, Karnataka and Tamil Nadu) have a Minimum Work Plan (MWP) of establishing 987 CNG stations and 98,91,912 PNG connections over the next 8-10 years. The details of the number of CGD projects authorized in Andhra Pradesh during the last five years, along with the list of CGD entities are as at **Annexure**:
