REVIVAL OF CLOSED MSMEs

689. SMT. GENIBEN NAGAJI THAKOR: SHRI ANAND BHADAURIA: DR. SHIVAJI BANDAPPA KALGE:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

(a) the steps being taken by the Government to promote Micro, Small and Medium Enterprises (MSMEs) along with the overall growth reported during the last five years;

(b) whether Government has any data on MSME industries/ MSMEs which got closed during COVID-19 period and also due to demonetisation in 2016, thereby making a large number of people unemployed and if so, the details thereof, State-wise;

(c) the assistance provided and other steps taken to help them revive after the ill effects of COVID-19 have come under control and the outcome of the efforts for their revival, State and year-wise;

(d) the number of such closed MSMEs which could not be revived, State-wise; and

(e) the number of new MSMEs opened during last five years, year and State-wise?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

(a) & (c): The Ministry of MSME launched Udyam Registration Portal (URP) on 01.07.2020. Since its inception till 24.11.2024, 3,11,33,299 enterprises with an employment of 20,37,73,324 have been registered on URP. To bring Informal Micro Enterprises (IMEs) under the formal ambit of MSMEs and for availing benefits under Priority Sector Lending (PSL), Udyam Assist Platform (UAP) was launched on 11.01.2023. Since then till 24.11.2024, a total of 2,39,30,414 micro enterprises with an employment of 2,84,91,516 have been registered on the portal. The Government has taken various initiatives to provide timely and adequate finances for MSMEs, which inter-alia include the following:

- Collateral free loans up to a limit of Rs. 500 lakh (w.e.f. 01.04.2023) to Micro and Small Enterprises, with guarantee coverage up to 85 % for various categories of loans through Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) under Credit Guarantee Scheme for Micro and Small Enterprises. Since inception in 2000-01 till 10.11.2024, a total of 98,02,086 guarantees amounting to Rs 7,61,898.64 crore have been issued.
- Under Prime Minister's Employment Generation Programme, credit linked subsidy for setting up new micro-enterprises in non-farm sector is provided. Margin Money subsidy ranging from 15% to 35% of project cost, for projects up to Rs. 50 Lakh in Manufacturing sector and Rs. 20 Lakh in the Service sector, is provided. For beneficiaries belonging to Special categories, including women, the margin money subsidy is 35% in rural areas and 25% in urban areas.

• The Emergency Credit Line Guarantee Scheme (ECLGS) was launched in May, 2020 as part of Aatmanirbhar Bharat Abhiyaan to support eligible MSMEs and business enterprises in meeting their operational liabilities and restarting their businesses in the context of the disruption caused by the COVID-19 pandemic. The Scheme was operational till 31.03.2023. This Scheme covered all the sectors of the economy. Under this, 100% guarantee was provided to Member Lending Institutions (MLIs) in respect of the credit facility extended by them to eligible borrowers. State and year wise details are given in Annexure-I. As per a research report dated 23.1.2023 of the State Bank of India on ECLGS, almost 14.6 lakh MSME accounts, of which about 98.3% of the accounts were in the Micro and Small Enterprises categories, were saved. In absolute terms, MSME loan accounts worth Rs. 2.2 lakh crore improved since inception of ECLGS for entire banking industry. Around 12% of the outstanding MSME credit was saved from slipping into non-performing asset (NPA) classification due to ECLGS.

(b) & (d): Enterprises de-register on the Udyam portal due to a number of reasons such as change in the company owner, certificate not required, duplicate registration, shut down of enterprises and such other reasons. The State/UT-wise details of MSMEs which shut down between 2020 and 2022 (From 01.07.2020 to 31.03.2022), are given at Annexure - II. The data of closed MSMEs which have not revived is not maintained centrally.

(e): The year-wise details of new MSMEs opened in each State/UTs, during the last five years, are given at Annexure – III.
