PROMOTION OF MSMES

3956. SHRI K C VENUGOPAL:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of the efforts made by Government to promote Micro, Small and Medium Enterprises (MSMEs) during the last five years, year and scheme-wise;
- (b) the number of MSMEs functional in Kerala, district-wise;
- (c) the number of beneficiaries under the various scheme during the last five years. State-wise; especially in Kerala; and
- (d) the details of the loans sanctioned and released for various MSME schemes in the State of Kerala during the said period?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a) to (c): Government helps in establishment, promotion and development of MSMEs in States/UTs through its various schemes, programmes and policy initiatives across the country. These schemes/ programmes, inter-alia, include Prime Minister's Employment Generation Programme (PMEGP), Credit Guarantee Scheme for Micro and Small Enterprises, Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Entrepreneurship Skill Development Programme (ESDP), Procurement and Marketing Support Scheme (PMSS), Raising and Accelerating MSME Performance (RAMP), International Cooperation scheme, Tool Rooms, Technology Centre System Programme (TCSP), National SC/ST Hub (NSSH), MSME Champions, PM Vishwakarma, etc. Ministry of MSME has taken various steps for the promotion and development of MSME sector, during the last five years. Some of these are detailed below:
 - i. New revised criteria for classification of MSMEs.
 - ii. "Udyam Registration" for MSMEs, for Ease of Doing Business w.e.f. 1.7.2020.
 - iii. Launching of an online Portal "Champions" in June, 2020 to cover many aspects of e-governance including grievance redress and handholding of MSMEs.
 - iv. Inclusion of Retail and Wholesale traders as MSMEs w.e.f. 2.7. 2021.
 - v. Launch of Udyam Assist Platform on 11.1.2023 to bring Informal Micro Enterprises (IMEs) under the formal ambit for availing the benefits under Priority Sector Lending.
 - vi. Equity infusion through Self-Reliant India Fund.
 - vii. Credit Guarantee Scheme revamped with required infusion of funds of Rs. 9,000 crore to facilitate additional credit of Rs. 2 lakh crore for MSEs and expand employment opportunities.
 - viii. Launch of 'PM Vishwakarma' Scheme on 17.09.2023 to provide end to end holistic benefits to the traditional artisans and craftspeopleengagedin18 trades.

The details of number of registered MSMEs functional in Kerala, district-wise are given at **Annexure** –**I.** The details of number of beneficiaries under some of these schemes of Ministry during the last five years are given at **Annexure** –**II.**

(d): The schemes implemented by the Ministry of MSME are Central Sector Schemes, where funds/loans are not allocated State/UT wise.

6. National Scheduled Caste and Scheduled Tribe Hub (NSSH)

"National Scheduled Caste and Scheduled Tribe Hub (NSSH) scheme is aimed at promoting entrepreneurship among the SC/ST and to fulfil the 4% procurement mandate by the CPSEs as laid down in the Central Government Public Procurement Policy and to boost entrepreneurship among SC/STs. Several initiatives have been taken under the Scheme to provide professional support to SCs-STs in skilling/capacity building, market linkages, finance facilitation, tender bid participation, etc.

7. International Cooperation(IC) Scheme:

International Cooperation (IC) Scheme is Central Sector Scheme of Ministry of MSME. As per IC Scheme guidelines, funds are not allocated/released State-wise / UT-wise / District-wise; instead, funds are released for facilitating MSMEs through industry associations/organizations spread across the nation on reimbursement basis for participation in international events. In Kerala State, total no. of enterprises assisted under IC scheme during the last 5 years [from FY 2020-21 to 2024-25(till 15.12.24)] is 9, with amount released being Rs **28,82,981**.
