FUNDS FOR FOOD PROCESSING UNITS UNDER CEFPPC SCHEME

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the details of the number of food processing units approved under Creation / Expansion of Food Processing and Preservation Capacities (CEFPPC) Scheme in Andhra Pradesh during the last five-years;
- (b) the details of the funds approved and released for the food processing units in Andhra Pradesh;
- (c) whether there are any delays in releasing the approved funds for these food processing units in Andhra Pradesh and if so, the details thereof;
- (d) whether the Government has invited fresh proposals under the said scheme during the last three-years and if so, the details thereof;
- (e) whether the Government has adequate funds for approval of fresh proposals under scheme and if so, the details thereof; and
- (f) the details of the funds allocated and utilized under the Scheme for Scheduled Caste Sub Plan (SCSP), in the country, State-wise and district-wise in Andhra Pradesh during the last five-years?

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a) & (b): Twelve (12) food processing units have been approved in the State of Andhra Pradesh by Ministry of Food Processing Industries (MoFPI) under the Scheme for Creation/Expansion of Food Processing & Preservation Capacities (CEFPPC) of the Pradhan Mantri Kisan Sampada Yojana (PMKSY) during last five years. The details of these units including grants-in-aid approved and released are as under:

(c): There is no delay in releasing the approved funds for these food processing units in Andhra Pradesh.

(d): Ministry issued Expression of Interest (EoIs) on 21.06.2022, 27.07.2023 & 04.10.2023 for inviting online applications from potential investors/ promoters for food processing projects under CEFPPC Scheme during last three years. Further, Ministry had recently issued Expression of Interest (EoI) on 27.01.2025 under CEFPPC scheme. The last date for submission of proposals is 28.03.2025.

(e): The Ministry receives large number of proposals against EoIs under CEFPPC component of PMKSY. However, the availability of funds is not enough to accord approval to all the eligible proposals.

(f): CEFPPC scheme is a demand driven scheme and is not State/District specific. The details of the funds allocated and utilized under the Scheme for Scheduled Caste Sub Plan (SCSP) during the last five years is as under:
