(iii) Covid-19 and the steps taken by the Government of india

THE MINISTER OF HEALTH AND FAMILY WELFARE AND MINISTER OF CHEMICALS AND FERTILIZERS (SHRI MANSUKH MANDAVIYA): Sir, In view of the global pandemic COVID-19, I would like to make a statement in the House.

Sir, the COVID-19 pandemic still continues to affect the health and livelihood of all across the world. Over the last three years, the ever-changing variants of the virus have posed a threat to global health, affecting almost every country. For the last several days, an increase in the cases of Covid-19 is being recorded all over the world. But for the last one year, there has been a continuous decline in COVID cases in India. At present an average of 153 new COVID cases are being registered every day across the country, against which 5.87 lakh new COVID cases are being registered every day across the world. Countries like Japan, South Korea, USA, France, Greece, Italy etc. are witnessing a continuous increase in the number of COVID-19 cases and deaths caused by COVID. There are also a high number of COVID cases and deaths being reported from China in the media since the last few days.

Under the leadership of the hon. Prime Minister, the Ministry of Health and Family Welfare has managed the COVID-19 pandemic from the very beginning with proactive, pre-emptive, whole of Government and whole of society approach and we have got very good outcome as a result thereof

Apart from technical assistance, the Government of India continuously supported the states in their efforts to fight against COVID by providing financial assistance to States through National Health Mission, State Disaster Response Fund, Emergency COVID Response Package and Prime Minister Ayushman Bharat Health Infrastructure Mission etc.... (Interruptions)

The Union Government and the State Governments together have created a record by administering 220.02 crore COVID doses in which vaccine both the vaccines have been administered to 90 percent of the eligible population and 22.35 crore population has also been given a precaution dose.... (Interruptions) As part of the ongoing efforts to control COVID-19 and in view of the increasing cases of COVID in the world, the Union Health Ministry is monitoring the Global situation.... (Interruptions) The Government is taking steps to address the challenges posed to public health by the changing variants of COVID-19.... (Interruptions) The States are also being advised to

increase community surveillance at the local level to control COVID.... (Interruptions) States have also been advised to increase the whole genome sequencing of all positive cases for timely detection of newer variants, if any, spreading across the country and take further measures on time required for public health.... (ii) Regarding setting up of a Sainik School in Godda/Deoghar

[English]

DR. NISHIKANT DUBEY (GODDA): I wish to draw your kind attention towards the backwardness of the Santhal Pargana region in general and the area(s) of Godda and Deoghar, in particular, which happens to be my Lok Sabha constituency. The overall condition of education in this region is a subject-matter of neglect despite the fact that since time immemorial, the entire region was considered to be a harbinger of ancient education practices and dissemination of social norms and mores. There has been a vociferous demand for establishing Sainik a School Godda/Deoghar so that this area could also share the pride of having quality education for their children.

In February, 2016, the then hon. Minister of Defence visited my constituency and after acknowledging the backwardness of the region, he was kind to announce the setting up of a Sainik School in Godda/Deoghar. Further, as a consequence to the said announcement, the project for establishing a Sainik School was immediately sanctioned by the Ministry of Defence. However, it is a matter of concern that since then, more than five years have elapsed, but the entire Project has not witnessed any visible progress.

# (iii) Need to take up construction of Sitamarhi-Laukahi railway line

[Translation]

SHRI ASHOK KUMAR YADAV (MADHUBANI): Hon. Chairperson, Sir, I would like to urge that the much-awaited new railway line from Sitamarhi to Nirmali via Sursand, Saharghat, Jaynagar, Laukahi which was envisaged and proposed to be materialized a decade ago, be started as soon as possible for the all-round development of the people of three border districts of Mithilanchal and this region.... (Interruptions) It may be noted that according to the news published in newspapers in March 2011 and April 2012, as has been quoted by the Railway sources, the survey of this Railway line was completed and the Railways had also

allocated 30 crore rupees for acquisition of land for this railway line and the process of land acquisition was also started. According to the information provided, Rs. 693 crore was estimated to be spent on the 6-year plan for the 189 kilometre long Railway line. This will reduce the distance of Sitamarhi and Madhubani districts from trans kosi districts of Saharsa and Supaul ... (Interruptions)

(iv) Need to run Sainik Express (Train No. 14021/22) with adequate No. of coaches and provide stoppage of Aravali Express at Bissau Railway Station, Rajasthan.

**KUMAR** (JHUNJHUNU): NARENDRA SHRI Hon. Chairperson Sir, Jhunjhunu District is a military dominated area and is an important part of Shekhawati region. Thousands of people travel by train every day from this region. The Sainik Express Train no. 14021/14022 has only 14 coaches, because of which people are facing a lot of problems as there is lack of seats therein.... (Interruptions) The Sainik Express Train no.14021/14022 should be run with full load (including 1 AC coach) having 24 coaches. Thousands of passengers have to face problems because there is no stoppage of even a single long distance train including Aravali Express (Sri Ganganagar to Bandra Train No. 14701/14702) at Bissau railway station. Stoppage of Aravali Express (Sri Ganganagar to Bandra Train 14701/14702) should be provided at Bissau railway station.... (Interruptions)

# SHRI VIVEK NARAYAN SHEJWALKAR (GWALIOR):

Chairperson Sir, on the occasion of Amrit Mahotsav of Independence, Amrit Sarovar Scheme was launched by the Prime Minister on April 24, 2022 for the construction of 75 ponds in each district across the country.... (Interruptions) The objective of the Amrit Sarovar Yojana is the construction of ponds and to plant trees around it to make them attractive for tourism and to raise awareness among the people about the significance of ponds.... (Interruptions) I am very happy to inform that 100 sites have been identified for Amrit Sarovar in my Gwalior district. 58 lakes have so far been constructed in Gwalior district. The villagers are getting a lot of benefits from the rainwater being conserved in these Amrit Sarovar. This scheme is turning out to be very effective for water conservation.... (Interruptions) Having seen the successful implementation of Amrit Sarovar Yojana in rural areas I would like to request that the Government should seriously consider the revival of old ponds and water storage sites in and around urban bodies and to launch an awareness campaign for rainwater harvesting.... (vi) Regarding development plan for widening of roads in Mumbai, Maharashtra.

[Translation]

SHRI GOPAL SHETTY (MUMBAI NORTH): Madam, today the popular Prime Minister of our country is trying to take the country's economy to 5 trillion dollars by the year 2027. This announcement has created great enthusiasm in the entire country especially among the youth and our Prime Minister is paying more attention to the development of industrial sector and Infrastructure development. For example, in our country, Rs.1.5 lakh crore was spent for the Infrastructure Development in the year 2011 and today it has been increased to Rs 7.5 lakh crore in the year 2022. Thus, it was not only decided to construct new roads, expand railway lines, airlines etc. across the country, but work at the ground level is also being carried out at a very fast pace. I would also like to inform the House that the Deputy Chief Minister of Maharashtra has promised that Maharashtra will contribute 1 trillion dollars in the making of 5 trillion dollar economy. Since Mumbai city is the economic capital of the country, the city of Mumbai will contribute significantly to this resolution of the State Government. It is a wellknown fact that a significant portion of the Union Government's revenue comes from Mumbai through various forms of taxation. However, it is noted that Mumbai city currently grapples with huge traffic congestion and during peak hours vehicles move at a speed of 10-15 kilometer per hour this issue affects not only the trading community but also the general public and working class resulting

in the loss of approximately four hours due to traffic congestion on a daily basis. I would like to apprise the House that under the leadership of the Hon. Prime Minister, the work of road construction being carried out by the Union Minister of Road Transport and Highways all over the country today was started from the economic capital of the country i.e. Mumbai city itself. Therefore, through this House, I demand from the Government that as the Union Government has contributed towards the Metro Rail for Mumbai city, in the same way, it may contribute towards solving the traffic problem here within a stipulated time frame by making financial contribution for the construction of all the roads mentioned in the Development Plan (DP) like widening the roads of Mumbai at a fast pace. I along with all the residents of Mumbai city would be thankful to the Government for this.... (Interruptions)

# (vii) Need to take stringent action against people involved in business of adulterated food items.

**SHRI MANSUKHBHAI DHANJIBHAI** VASAVA (BHARUCH): Madam, currently, farmers are in the race of earning more profit by boosting crop yields through the excessive use of pesticides on fruits and vegetables, however, the same fruits and vegetables, intended to maintain health and youthfulness, are adversely affecting human life. Contaminated Fruits and vegetables are causing more harm to the body than benefit. Consumption of pesticide-contaminated fruits and vegetables are causing serious diseases like cancer. There was a time in our country when milk was available in abundance but now there is adulteration in everything, and milk has not remained unaffected to it. Consumption of adulterated food and beverage is equivalent to playing with one's health. In this context, I would like to urge upon the Government to take immediate and stringent action against those involved in the illicit trade of selling adulterated goods, including the farmers driven by greed, by imposing a ban on such activities

# (viii) Regarding death of migrant workers of Bihar in other States

[English]

SHRI RAJIV PRATAP RUDY (SARAN): Recently, there has been an alarming rise in the number of cases in which migrants from Bihar have lost their lives in other States. More than half of the households in Bihar have male members of their family who have ventured out in search of jobs and better remuneration. The highest migration takes place from the pockets of Saran, Munger, Darbhanga, Kosi, Tirhut and Purnia. In Delhi alone, 18 per cent of all the migrants come from Bihar. The average age of the migrants is 32 years and more than 90 per cent of them work in private factories or are engaged as casual workers. Reports have highlighted the rising number of incidents in which migrant workers from Bihar have lost their lives. On 5th August 2022, one worker was killed and 2 others were injured in Jammu and Kashmir by terrorists. Tragic deaths have been reported, ranging from causes such as collapse of buildings which killed three brothers from Chapra, accidents involving fires where eleven workers from Bihar perished, as well as the death of four laborers from Bihar in road accidents. These cases highlight the lack of a robust safety and security mechanism when it comes to the protection of migrant

workers from Bihar as well as migrants in general in their areas of employment. There is thus an imminent need to address this issue and ensure that more precious lives of workers from Bihar and across the country are not lost due to such tragic and avoidable incidents.

# (ix) Need to set up warehouses at panchayats and block levels for storage of agricultural produce in Maharajganj Parliamentary Constituency

[Translation]

# SHRI JANARDAN SINGH SIGRIWAL (MAHARAJGANJ):

Hon. Chairperson, my parliamentary constituency Maharaganj, Bihar is an agro-based predominantly rural area. There is acute shortage of warehouses for the safe storage of crops produced by the farmers here. The financial condition of the farmers is not such that they may afford to build warehouses on their own. The process of constructing warehouses with the financial aid from the Government is not so simple that farmers avail such benefits and get such warehouses built easily. In the backdrop of the shortage of safe warehouses, farmers are compelled to sell their produce at lower prices causing financial loss to them.

Therefore, I would like to urge upon the Government to construct modern warehouses of small or medium capacity at the panchayat or block level in the rural areas of my parliamentary constituency Maharajganj, Bihar so that farmers are benefited.

# (x) Regarding construction of Railway Over Bridge at levelcrossing No. B/159 on Bhidi-Samdari Railway Station in Gujarat

**SHRI PARBATBHAI SAVABHAI PATEL** (BANASKANTHA): Hon. Chairperson Madam, under my parliamentary constituency Banaskantha L.C. No. B/159 is situated on the Bhildi - Samdadi section railway line. Highway No. - 54 of the State of Gujarat which is four lane and is located between Deesa and Tharad crosses this LCB/159. It is known that the state road passes through five to six talukas of my parliamentary constituency, Banaskantha. Thanks to dense population and increased traffic in this area, we have been demanding the construction of a ROB from the railway authorities since long. The Government of Gujarat has also sanctioned 50% funds for the construction of ROB, but no action has so far been taken by the Railways for the construction of this ROB. ... (Interruptions)

Therefore, I would like to request the Hon. Minister of Railways to include the construction of this ROB in the forthcoming Budget as well as in the Pink Book of the Railways. ... (Interruptions)

# (xi) Regarding remedial measures to prevent road accidents in the country

SHRI BRIJENDRA SINGH (HISAR): Hon. Chairperson Madam, now a days road safety is a major issue. Unsafe roads often make the daily movement of drivers pathetic. Accident prone areas, unauthorized road crossings, potholes, the sudden appearance of stray animals on the road and insufficient lighting at night are the major factors causing road accidents. According to the data provided by the traffic police, 10 to 11 thousand road accidents took place every year in Haryana in which about five thousand people die. All these accidents are caused by unsafe roads. Dainik Jagran's reporter together with road experts audited 218 major roads of 6227-kilometer length in 22 districts and found that 255 roads are bottlenecked, there are 377accident-prone areas and 1013 illegal cuts, 104 roads do not have street lights and 725 roads have defective designs. ... (Interruptions)

In this context, I would like to urge upon the Union Government to issue necessary guidelines to the concerned Department to remove the shortcomings highlighted in the survey with immediate effect so that the recurrence of such accidents may be checked. In addition, to address the deficiencies in road design

and ensure regular and proper maintenance of roads, I propose that an expert advisory committee may be constituted. ... (Interruptions)

(xii) Need to start train services from Bhupdevgarh to Dharamjaigarh and from Dharamjaigarh to Raipur in Chhattisgarh

SHRIMATI GOMATI SAI (RAIGARH): The Rail Corridor Project from Bhupdevpur to Dharmajaygarh has been completed and in this corridor coal transportation by goods trains has been continuously going on since November 2019. The passenger train services have not commenced till date in this corridor despite having the provisions for running the same. All construction and necessary arrangements for passenger train operations such as ticket counters, stations and platform work have been completed. The Dharamjaygarh region is a tribal area where people have had a longheld dream of travelling by train to the district headquarters of Raigarh and the capital city of Raipur by train.

Passenger trains should be run from Dharamjaygarh to connect Jharsuguda and the capital, Raipur via the district headquarter of

Raigarh. I would also like to draw the attention of the Government towards expansion of passenger amenities at Raigarh railway station. The railway station is located in the middle of district headquarters city of Raigarh. The city is situated on both sides of the station. One has to go around the entire city to reach the main platform. Therefore, there is an urgent need to construct a platform, new ticket counter, vehicle stand and foot over-bridge opposite to the main platform in the South for the convenience of the passengers. Further, the differently abled and the elderly people have to face difficulty in reaching from one platform to another through stairs. Hence, all the specialized facilities meant for persons with disabilities and the elderly should be set up.

# (xiii) Need to introduce rail service from Gaya to Daltonganj

SHRI SUSHIL KUMAR SINGH (AURANGABAD): The parliamentary constituency of Aurangabad is spread over two districts of Gaya and Aurangabad. Both these leftist extremism affected districts are included in the list of aspirational districts declared by the Government of India, however, in the last decade, the Union Government's developmental schemes and the Ministry of Home Affairs' special initiatives have led to considerable progress in implementing development plans and road connectivity in these aspirational districts and the increased road connectivity has accelerated the pace of development, and as a result, it has been now possible to curb extremism.

The two districts, Gaya and Aurangabad in southern Bihar are adjacent to the insurgency-affected districts of Jharkhand such as Chatra and Hazaribagh. Local residents have been demanding the extension of rail services to connect Daltonganj in Jharkhand via Gaya, Sherghati, Banke Bazar, Imamganj, and Dumaria in Bihar. This extension of rail services would be instrumental in better local connectivity and also in controlling insurgency.

# (xiv) Need to enhance the honorarium of Aanganwadi workers

SHRIMATI RAMA DEVI (SHEOHAR): The Integrated Child Development Services (ICDS) project, aimed at the nutrition and educational development of children up to 6 years, known as the Anganwadi Scheme was launched by the Union Government under which Anganwadi Sevika and Sahayika are taking care of health and education needs of children even in the rural areas of the country. In my home state of Bihar as well as all across the country, millions of women work as Anganwadi Sevika and Sahayika providing care and contributing significantly to the intellectual development of children, however, they are not being paid adequate honorarium for their commendable contributions. At the beginning of the programme, Anganwadi Sevika and Sahayika were appointed at a very low honorarium, although there have been occasional increases, they are not sufficient to keep up with inflation. For this, Anganwadi Sevikas and Sahayikas are agitating

Therefore, I would like to urge upon the Government to increase their honorarium in line with inflation in view of the difficulties faced by Anganwadi Sevikas and Sahayikas working in Anganwadi centres and accord the status of government employees to them.

# (xv) Regarding appointment of an Additional Director to oversee the CGHS Aarogya Kendras at Ajmer, Jodhpur and Kota in Rajasthan

SHRI BHAGIRATH CHOUDHARY (AJMER): In April 2019, 33 postal dispensaries of the country were merged into CGHS under which Ajmer, Jodhpur and Kota dispensaries in Rajasthan state were also merged into CGHS and their administrative control was brought under the AD, CGHS, Jaipur. As a result, pensioners from these three locations are forced to travel repeatedly to Jaipur for various works such as getting cards, card renewal and getting banned medicines etc. This has enhanced the workload on AD office, Jaipur. It is noteworthy that in Rajasthan, Ajmer has the highest number of pensioner cards as compared to Jodhpur and Kota Wellness Centers. Jodhpur has 1060 and Kota has only 299 pensioner cards whereas Ajmer has 1228 pensioner cards. Since, Ajmer is also situated amid Jodhpur and Kota. Earlier, all the posts of DDG Medical in the Department of Posts were merged with Postal Dispensaries in CGHS. There were also 05 posts of DDG Medical which were merged from postal dispensaries into CGHS, so out of these, 01 post can be given to Ajmer for the new AD office. Therefore, please direct the department to approve a new post of Additional Director in Ajmer for Ajmer, Jodhpur, and Kota Wellness Centers in the current financial year 2022-23. In addition,

it is necessary to approve the budget for the regular maintenance and renovation of the existing building, which is a 100-year-old building of the postal department and at the same time, steps should be taken to fill up the vacant posts out of the sanctioned strength at the earliest.

### (xvi) Regarding rising trade deficit with China.

[English]

SHRI GAURAV GOGOI (KALIABOR): Post-June 2020, India's imports from China surged despite the Galwan clash. The trade deficit with China was 73.31 Billion USD in 2021-22. The 'country of origin' tag in the GeM portal won't automatically make India self-reliant. If the Government believes so, it should explain how the measure has impacted the trade. The Finance Minister says that the Government takes the 'capital expenditure route' to guarantee growth. The same Government has informed the House that 'most of the goods imported from China are', inter alia, 'capital goods'. The Government imports capital goods from China amidst border tensions even after Governing for eight years and taking the socalled 'capital expenditure route'. India's laptop imports surged tremendously during 2022. Fully manufactured laptops make up the largest quantity of fully manufactured imported items from China. This trend is amidst cyber-attacks on servers at AIIMS from IP addresses of emails from China. Ever since the border tension between India and China in May 2020, Chinese hacker groups had been continuously targeting Indian Public Sector Companies. I demand the Government to explain why India's exports to China have fallen by 36.4% in January-September 2022 whereas India's imports from China have risen by 31% amidst border tensions.

## (xvii) Regarding preliminary Satellite Survey Report on human habitations in buffer zones in Kerala

SHRI K. MURALEEDHARAN (VADAKARA): Eco-Sensitive Zones (ESZ) areas are notified in India around Protected forests, National Parks and Wildlife Sanctuaries. The purpose of declaring ESZs is to create some kind of 'shock absorbers' to the protected areas by regulating and managing the activities around such areas.

Recently, Preliminary Satellite Survey Report prepared by the Kerala State Remote Sensing and Environment Centre has been released to ascertain the buffer zones in the State. Serious concerns have been raised over the preliminary satellite survey report on human habitations in eco-sensitive zones or buffer zones.

The report's lack of clarity has led to widespread complaints. In my Parliamentary Constituency, Vadakara, there is a vast area adjacent to the protected forests. Villages like Chakkittapara, Koothali, Changaroth, Maruthongra etc. are located in the buffer zone of the Malabar Protected Forest. The residents of these areas are confused due to the lack of clarity in the Preliminary Satellite Survey Report. The report says that there are 49,330 buildings in the buffer zone across the State. It is factually incorrect. There are

more than two lakh buildings in the buffer zone. Many of survey numbers have wrongly been given and locations have not been clearly indicated.

Hence, I request that field survey in the above context should be done properly.

### (xviii) Regarding payments made under the MSME Delayed Payment Act, 2016

SHRI BALUBHAU ALIAS SURESH NARAYAN DHANORKAR (CHANDRAPUR): Minister of MSME, Government of India has passed MSME Delayed Payment Act, 2016 but the proceeding involve takes too much time for getting Recoveries for supply of materials and payment pertaining to provided services. Approximately, 60% of the MSME's after Award from MSME Council could not get payment in time.

I propose that on supply of manufacturing both the State and Central Governments should get GST from Supplier MSME and on delayed payment from the buyer industries. If payment is not received by the MSME, the GST account of the defaulter i.e, Buyer of goods and services be suspended and in order to make payment and honour commitment the bank account should also be frozen

This strengthened system of ensuring payment of delayed Payment in time would save crores of MSME's in India. Minister of MSME, Government of India has passed MSME Delayed Payment Act, 2016 but the proceeding involve takes too much time for getting Recoveries for supply of materials and payment pertaining to provided services. Approximately, 60% of the MSME's after Award from MSME Council could not get payment in time.

# (xix) Regarding upgradation in pay structure of the supervisory staff of Indian Railways

DR. D. RAVIKUMAR (VILUPPURAM): The Honorable Minister of Railways during his video conference on 16th November had categorically stated that all the supervisory staff of Indian Railways will receive the benefit of upgradation of pay structure from GP-Rs. 4,600/- to Rs.4,800/- and Rs.5,400/- but the same has not been accorded to all the supervisory officers of RPF till now. Essentially, some departments of the RPF have received this upgradation, while others have not. This is violative of the equality clause as envisioned under Article 14 of the Constitution of India. The Inspector cadre in RPF is vital for the Force and they work in the frontline 24x7 for ensuring the smooth running of the Railway system. Due to denial of the same, in addition to being deprived of timely promotion, they are also omitted from the upgradation of pay structure which, if implemented, could have relief provided much needed their promotional a to disappointments.

It is also to be noted that promotions have been stagnant in the Indian Railways. It is requested that this may also be looked into. Lack of timely promotions may have the effect of dejection and

poor quality of work in the employees of the Indian Railways. As per Section 10 of RPF Act 1957, RPF personnel are treated as Railway employees and as such the above referred upgradation is also applicable to Railway Supervisory Officers. In the light of this, it is requested that the pay structure be upgraded and that pay be granted.

### (xx) Regarding power dues of Andhra Pradesh to be received from Telangana.

#### SHRI BELLANA CHANDRA SEKHAR (VIZIANAGARAM):

Post the bifurcation of the United Andhra Pradesh, the Andhra Pradesh Generation Corporation Limited (APGENCO) continued to supply power to Telangana till 10.06.2017 on the specific direction of the Central Government controlled POSOCO letter which was contrary to the decision taken by the Government of Andhra Pradesh. However, till date a sum of Rs. 6,886 crores awaits to be received from Telangana on account of the power supplied. In this regard, The Government of India, in the exercise of the powers granted under Section 92 of the AP Reorganisation Act, 2014, gave directions in the month of August this year that the Successor State of Telangana shall pay the appropriate sum to Andhra Pradesh within a period of 30 days. The order stated that there was no dispute regarding the amount to be paid for the power dues, the principal amount being Rs 3,441.78 crore, and late payment surcharge being Rs 3,315.14 crore (up to July 31, 2022) — to be paid in addition to the principal amount as per the applicable provisions. However, the Government of Telangana has not honoured the given directive. In view of the above, I request the Government to look into the matter.

# (xxi) Need to enhance the quota of appointments on compassionate ground in companies carved out of Ordnance Factories

[Translation]

SHRI SHRIRANG APPA BARNE (MAVAL): The Ministry of Defence has initiated the process of appointment on compassionate grounds again vide letter of the Director General of Ordnance Factories dated 10/10/2021 after the division of 41 ordnance factories into 7 companies, but it has not been clearly stated in this order whether such appointments will be made as per the rules of Union Government or as per the rules of the corporation. Currently, approximately three thousand appointments are lying pending in ordnance factories and the number of dependents to be appointed in place of the employees died during Corona period is very high, nevertheless no appointments have been made from 2019 till now, even though the Prime Minister has announced ten lakh jobs. In the appointments that currently being made, 5 are compassionate quota has been implemented. But despite providing 5 percent quota in the Ordnance Factory, all the eligible dependents are not getting appointed on the compassionate grounds. Failure to appoint all the eligible dependents on compassionate grounds even

after the division of Ordinance factories into 7 companies, may create social contradiction in the coming days.

Therefore, the Ministry of Defence is requested to increase the quota of compassionate appointments in the ordnance factories by more than 5 percent and to provide a one-time exemption to the dependents of deceased employees to appoint them in the ordinance factories.

### (xxii) Need to develop Jehanabad Railway station in Bihar as a Model Station

SHRI CHANDESHWAR PRASAD (JAHANABAD): The railway station and bus stand of a city are important yardstick of its beauty. The city of Jahanabad appears quite underdeveloped on this scale. The city's railway station is suffering from the lack of basic passenger amenities. However, it was announced in the Union budget to make it a model railway station in the year 2014. There was a discussion over the issue of developing several stations as model stations in the budget. Wherein Jahanabad was also primarily included. Currently, no headway has been made in this direction. The situation is such that an unauthorised auto stand has cropped up in the station premises. There is also a public toilet available in the premises, but without proper cleanliness. There is a separate toilet facility for male and female passengers built on the platform number two. But due to the lack of cleanliness, it has become unusable. The shops operated on the encroached land have undoubtedly been removed from the premises by the railway but the arbitrary behaviour of auto drivers still continues. It was necessary to develop the circulating area of the station under the model station with facilities such as restrooms, waiting rooms, bathing facilities, separate waiting rooms for women, computerbased announcements, signage, pay-and-use toilets, water coolers,

raising platform heights, construction of FOB, and construction of ramps, etc. in the circulating area to develop the stations. However, any of the schemes under the model plan has not yet been implemented at this station.

I would like to request the Hon. Minister of Railways to ensure that all passenger amenities at Jehanabad station are provided as per the Model Station Scheme.

### (xxiii) Need to provide free electricity to farmers and interest free loans through Kisan Credit cards

SHRI RAMSHIROMANI VERMA (SHRAWASTI): I want to draw the attention of the Government towards the farmers of the country. Today the farmers of our country are very upset. The main issue of farmers is the significant increase in agricultural costs. For example, prices of DAP, urea, potash, seeds, pesticides, etc. have increased many folds. Along with this, the cost of diesel and electricity has also increased due to inflation.

The Government is requested to increase the price of sugarcane by approximately Rs.500 per quintal at the earliest, considering the serious problems being faced by farmers, besides, it should be ensured that the outstanding amount for sugarcane of farmers owed by the Bajaj sugar mill in Balrampur district of our parliamentary constituency is paid to them as soon as possible.

The price of farmers' crops should also be increased in proportion to the cost. Besides, providing free electricity to the farmers, interest on KKC loan of the farmers should also be waived off.

### (xxiv) Regarding sanctioning of an Indian Institute of Science Education and Research (IISER) at Hyderabad

[English]

SHRI B.B. PATIL (ZAHIRABAD): The Government of India has started seven Indian Institutes of Science Education and Research (IISER) since 2006 as a part of the Higher and Technical Education Policy. However, Hyderabad was not given the opportunity. The Higher Education Research Eco-System in Hyderabad comprises Indian Institute of Technology (IIT), International Institute of Information Technology (IIIT), Indian Institute of Chemical Technology (IICT), National Geophysical Research Institute (NGRI), Centre for Cellular and Molecular Biology (CCMB), National Institute of Nutrition (NIN), Indian School of Business (ISB), etc., which would provide an excellent opportunity to nurture IISER, given its objective as a Centre of Excellence dedicated to the objectives of science and research in basic sciences.

Therefore, it is requested to sanction an IISER in Hyderabad, given the vast amount of research ecosystem available in the city with related institutes as the State Government is ready to provide the required and suitable land for the establishment of IISER.

### (xxv) Need to develop Sikandarpur stadium in Muzaffarpur district as a world class cricket stadium

[Translation]

SHRIMATI VEENA DEVI (VAISHALI): To encourage sports in Muzaffarpur district, the largest business center and education hub of North Bihar, Sikandarpur Stadium should be expanded and upgraded into a cricket stadium of international level. This district has also been selected to be developed as smart city. The construction of an international-level cricket stadium will provide impetus to the growth of the district leading to a significant increase in Government revenue

MOTION TO REFER JAN VISHWAS (AMENDMENT AND PROVISIONS) BILL, 2022 TO THE JOINT COMMITTEE [Translation]

THE MINISTER OF COMMERCE AND INDUSTRY; MINISTER OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION AND MINISTER OF TEXTILES (SHRI PIYUSH GOYAL): Hon. Chairperson Madam, there are many such laws in our country under which people are punished for minor mistakes, forcing them to face the courts, and subjecting them to legal action.... (Interruptions) Our Government believes that we should trust the people, we should have faith in the people.... (Interruptions)

Generally, be it businessmen or general public, they want an honest system. They lead their lives with honesty and run their business with integrity. Sometimes, they also make mistakes.... (*Interruptions*) In such a situation, we believe that they should not have to go to the courts for small mistakes. For this, we should make provisions that if there is any mistake, the person should be punished, but they should not face any problem.... (*Interruptions*)

Since 2014, our Government has been consistently making various decisions to make the lives of the people easier. You must have noticed that the first decision taken was about self-attestation

so that people do not have to go to a notary, we can attest the documents with our own signature.... (*Interruptions*) Similarly, there is a new law like GST, through which a significant change has been made in the tax system. The Government of the Hon. Prime Minister, Narendra Modi Ji has taken various initiatives, which have had a significant impact on the Ease of Doing Business and the Ease of living.... (*Interruptions*)

We want that investors from across the country and the world who come to India should get a red carpet instead of red tape. We have worked hard for many years for the same.... (Interruptions) Even in the ranking of Ease of Doing Business, our global rank which was 141, has leaped forward to 63 today.... (Interruptions) I believe that the entire Government is currently working hard together. We have repealed approximately 1,500 archaic laws with the help of the Whole of the Government.... (Interruptions)

Approximately 39, thousand compliances have been simplified and nearly three and a half thousand provisions have been introduced providing relief to people by de-criminalising them.... (*Interruptions*) We believe that reducing this compliance burden will also simplify things and make people's businesses and lives easier by using modern technology.... (*Interruptions*)

Hon Chairperson Sir, in this law, due to the unique imagination of the Hon. Prime Minister, the work of decriminalising 183 provisions in one Act i.e. 183 provisions in 42 laws of 19 different ministries has been done through this law.... (*Interruptions*) We believe that the trust of people and the trust of business and industry are of paramount importance.... (*Interruptions*) This will also reduce the burden on the courts and hence it has been named 'Jan Vishwas (Amendment of Provisions) Bill, 2022'.... (*Interruptions*) [English]
