- (a) whether the Government provides funds from the Central pool to the States for large irrigation schemes, water management and construction of high dams; and
- (b) if so, the details thereof along with the funds provided for the purpose during the last three years and the current year, State and project-wise?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (b) OF STARRED QUESTION NO. *272 TO BE ANSWERED ON 07.08.2025 IN LOK SABHA REGARDING “FUNDS FOR IRRIGATION AND WATER MANAGEMENT”

(a) Water resources projects are planned, funded, executed, and maintained by the State Governments themselves as per their own resources and priorities. Role of Government of India is to provide technical support and, in some cases, partial financial assistance under the existing schemes implemented by the Ministry of Jal Shakti, including partial financial assistance for large irrigation schemes and command area development and water management.

(b) Pradhan Mantri Krishi Sinchai Yojna (PMKSY) is an umbrella scheme, consisting of two major components, namely, Accelerated Irrigation Benefits Programme (AIBP), and Har Khet Ko Pani (HKKP) implemented by Ministry of Jal Shakti. HKKP, in turn, consists of one of the sub-components, namely, Command Area Development and Water Management (CAD&WM) being implemented pari-passu with AIBP.

AIBP component focuses on completion of major, medium and Extension, Renovation and Modernisation (ERM) projects for creation of new irrigation potential/restoration of irrigation potential in the country. CAD&WM is dedicated to command area development and participatory irrigation management through water user associations.

Further, a special package for completion of 8 MMI and 83 surface minor irrigation (SMI) projects in Vidarbha, Marathwada and other drought prone areas of Maharashtra, has been approved for partial financial assistance by Government of India during 2018-19.

In addition, projects included under National Projects scheme of Ministry of Jal Shakti are partially funded by this Ministry either under PMKSY-AIBP or separately.

Further, mother sanctions of Rs. 850.17 crore and Rs. 69.74 crore have been issued to different projects against central assistance for financial year 2025-26 under PMKSY-AIBP and CAD&WM, respectively, against which States have yet to incur the expenditure.
