Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

- (a) the total number of integrated textile parks sanctioned under the scheme, State-wise and year of approval;
- (b) the details regarding the physical and financial progress of the approved parks, classified State-wise;
- (c) the total number of units operational in Andhra Pradesh from the proposed units;
- (d) the mechanisms or regulatory bodies in place to monitor the functioning of approved units;
- (e) whether the Government have any details regarding the total number of employment generated under the scheme; and
- (f) if so, the details thereof. State-wise?

उत्तर ANSWER वस्त्र राज्य मंत्री (**श्री पबित्र मार्घेरिटा**) THE MINISTER OF STATE FOR TEXTILES (SHRI PABITRA MARGHERITA)

(a) to (f): With a view to increasing investments, generating employment opportunities and boosting exports in the textile sector, the Ministry is implementing Scheme for Integrated Textile Park (SITP) to provide support for setting up textile parks with world-class, state-of-the-art infrastructure in textile hubs across the country. The scheme was in implementation upto31.03.2021; however, the Scheme has now been subsumed under the umbrella Scheme of Textile Cluster Development Scheme (TCDS) for completing ongoing projects only.

The Ministry conducts regular monitoring of approved project through Project Management Consultant (PMC) and office of Textile Commissioner. PMC conducts tracking of physical and financial milestones and to ensure compliance with agreed timelines and quality standards.

Under the said scheme, 50 parks were sanctioned including 4 parks in Andhra Pradesh. Out of 50 parks, 30 parks have been completed and 20 projects are under various stages of implementation. As of now, GoI share of Rs. 1,532 crore has been released and employment of 1.23 lakh people has been generated. The state-wise details of these projects are at Annexure.

Apart from above, the Ministry has also finalized PM Mega Integrated Textile Regions and Apparel (PM MITRA) Parks at 7 sites viz. Tamil Nadu (Virudhnagar), Telangana (Warangal), Gujarat (Navasari), Karnataka (Kalaburagi), Madhya Pradesh (Dhar), Uttar Pradesh (Lucknow) and Maharashtra (Amravati) with an outlay of Rs. 4,445 cr for a period of seven years upto 2027-28.
