INDIA POST PAYMENTS BANK (IPPB)

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether the Government is aware that the India Post Payments Bank (IPPB) has established 37 branches and over 10,952 access points across Tamil Nadu leveraging the Department of Posts infrastructure to deliver financial services and if so, the details thereof;
- (b) the details of the number of postmen and Gramin Dak Sevaks currently equipped and trained in Tamil Nadu to provide doorstep banking services and the scope of services being delivered through this model;
- (c) whether doorstep banking under IPPB in Tamil Nadu has significantly contributed to financial inclusion particularly in rural and unbanked areas and if so, the details thereof;
- (d) the number of rural post offices in Tamil Nadu currently offering IPPB-enabled banking services and the year-wise growth in digital and financial transactions recorded in the State; and
- (e) whether the Government has any plans to further expand IPPB's operations and digital infrastructure in Tamil Nadu and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR COMMUNICATIONS AND RURAL DEVELOPMENT (DR. PEMMASANI CHANDRA SEKHAR)

- (a) Yes Sir, India Post Payments Bank (IPPB) has established 35 Banking Outlets and 10,981 Access Points across Tamil Nadu leveraging the Department of Posts infrastructure to deliver financial services. District wise details of these Banking Outlets and Access Points across the State is at **Annexure-I**.
- (b) A total of 16,858 Postmen & Garmin Dak Sevaks are currently equipped and trained in Tamil Nadu to provide doorstep banking services that include Cash deposit/ withdrawal from Saving Accounts, Digital Life Certificate (DLC) for pensioners, mobile number update in Aadhaar for citizens and Child Enrolment Lite Client (CELC) services.
- (c) Yes Sir, IPPB has significantly contributed to financial inclusion by enabling account opening for more than 66 lakh customers who can now receive DBT directly into their bank account; providing Digital Life Certificate (DLC) for 7.96 lakh pensioners; and CELC services at doorstep of the customers of rural & unbanked areas in Tamil Nadu.
- (d) 8,800 Rural Post offices in Tamil Nadu are currently offering IPPB enabled Banking services. Year wise growth in digital and financial transactions is at **Annexure-II**.
- (e) No Sir. All the Post Offices of the Department of Posts are already providing IPPB services across the State.
