(b) The Central Government approves the State Plans and provides the Central Assistance (CA) to the States. The projects are selected, designed, approved and executed by the States/UTs and the cities. The State Governments release funds to the cities/districts. Further, PM SVANidhi is a Central Sector Scheme. Loans are disbursed by the Lending Institutions under the scheme and no fund is released to the State Governments/UTs/Districts.

(c) Smart Cities Mission has ended on 31.03.2025. Under the PM-eBus Sewa Scheme, 400 e-buses have been sanctioned for the State of Odisha including 100 e-buses for Cuttack and 1st Tranche of Rs. 47.72 Cr. have been released to Odisha including Rs. 10.52 Cr for Cuttack for the development of associated infrastructure.
