IMPLEMENTATION OF NTCP

**1056. SHRI TANGELLA UDAY SRINIVAS:
SHRI G. LAKSHMINARAYANA:**

Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the current status of implementation of the National Tobacco Control Programme (NTCP) across the country including number of districts covered, Tobacco Cessation Centres established and key interventions undertaken, State/UT-wise;
- (b) the details of funds allocated, released and utilised for NTCP during last five years, year-wise and State/UT-wise;
- (c) whether the Government has conducted any assessment of the effectiveness of NTCP in achieving reduction in tobacco use, improvement in quit rates and control of tobacco-related diseases and if so, the details thereof;
- (d) whether the Government's current monitoring of NTCP relies largely on activity-based indicators such as the number of campaigns or sessions conducted, rather than on outcome-based measures like actual decline in tobacco consumption and burden of disease and if so, the details thereof; and
- (e) whether the Government proposes to reform NTCP's monitoring and evaluation framework to focus on measurable outcomes including reduction in tobacco prevalence and the economic impact of tobacco use and if so, the details thereof?

**ANSWER

(a): The Government of India launched the National Tobacco Control Programme (NTCP) in the year 2007-08 with the aim to reduce tobacco consumption and minimize the health burden caused by tobacco-related diseases. Currently the program is implemented in all 36 States and UTs covering more than 700 districts.

India has over 2,000 Tobacco Cessation Centres (TCCs) that have been established across the country under integrated efforts of NTCP, National Medical Commission (NMC) and National Dental Commission (NDC). Some of the key interventions and thrust areas under the program are:

- Setting-up and strengthening of cessation facilities including provision of pharmacological treatment facilities at district level.
- Training of health and social workers, NGOs, school teachers, and enforcement officers;

- Information, education, and communication (IEC) activities;
- Organizes an annual 60-day Tobacco-Free Youth Campaign;
- Monitoring of tobacco control laws;

(b): Under NTCP funds are released to 03 (three) National Tobacco Testing Laboratories and 04 Tobacco Quit Line Centers. The details of funds allocated and utilized during the last 05 (five) years are given below:

Further, for implementation of NTCP in States/UTs, funds are released through NCD Flexipool of National Health Mission (NHM) of Ministry of Health and Family Welfare. The details of funds provided to States/UTs by the NHM are at Annexure.

(c) to (e): The Government of India has undertaken periodic assessments of NTCP initiatives through Global Adult Tobacco Survey (GATS) and Global Youth Tobacco Survey (GYTS) which measure outcome-based indicators such as prevalence of tobacco use at the national and sub-national levels, users desirous of quitting tobacco etc. As per the Global Adult Tobacco Survey (GATS), 2016-2017, overall tobacco use was 28.6% which is a 17.3% relative reduction from 34.6% reported in 2009–2010.
