**IMPLEMENTATION OF HAR GHAR JAL SCHEME IN MAU DISTRICT OF
UTTAR PRADESH**

5359. SHRI RAJEEV RAI:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of piped water connections provided under the Har Ghar Jal Scheme in households of Mau district of Uttar Pradesh, separately for rural and urban areas;
- (b) whether all households in Mau district have been covered under the Scheme and provided with piped water connections and if not, the reasons therefor;
- (c) whether the Government has undertaken any assessment of the quality of work being done by the contracting agencies in implementing the Scheme and if so, the details thereof;
- (d) whether the infrastructural damage due to excavation of drains, roads, sewer lines, etc., for laying pipelines under the Scheme has been restored in the localities of Mau district where the Har Ghar Jal Scheme has been implemented; and
- (e) if so, the details thereof and if not, the reasons therefor?

ANSWER

(a) Government of India is committed to make provision for safe & potable tap water supply in adequate quantity, of prescribed quality and on a regular & long-term basis to all rural households in the country. Towards this end, the Government of India launched the Jal Jeevan Mission (JJM), being implemented in partnership with States, since August 2019. The Government of India supports the States by providing technical and financial assistance.

The details of piped water connections provided under Har Ghar Jal Scheme in households of Mau district of Uttar Pradesh for rural areas are available on JJM IMIS Dashboard at <https://ejalshakti.gov.in/jjmreport/JJMIndia.aspx>.

Under AMRUT, 170 water supply projects worth Rs. 4,267.71 crore taken up in Uttar Pradesh State out of which works worth Rs. 4,145.62 crore have been physically completed. 9.29 lakh water tap connection (new/serviced) have been provided under AMRUT & Convergence

Under AMRUT 2.0 so far, 420 water supply projects worth ₹21,209.76 crore have been approved by MoHUA in Uttar Pradesh. Approved projects cover 63.22 lakh new/service tap connections.

Under AMRUT, 3 water supply projects worth ₹26.37 crore taken up in Mau district. All 3 projects have been completed. 7,943 water tap connections (new/serviced) have been provided under AMRUT & Convergence.

Under AMRUT 2.0 so far, 4 water supply projects worth ₹377.88 crore have been approved by MoHUA in Mau district. Approved projects cover 92,303 new/service tap connections.

(b) As per JJM IMIS Dashboard, 28,230 Households in Mau district are still to be provided with FHTC as on 01.04.2025. As informed by the state government, the main reasons for delay are Covid-19 Pandemic, clearance from Different Departments (Like Railways, NH, PWD and expressway) for crossing of pipeline or drain/road cutting, delay in acquiring Land for the project, non-availability of material (Like D.I. Pipe etc.) on time.

(c) To ensure the quality of the work under the operational guideline for the implementation of the JJM, third party inspection and certification before payment is mandatory. For the purpose, States have been empowered to empanel third party inspection agencies (TPIA) to check the quality of work executed by the agencies, quality of materials used for construction and quality of machinery installed in each of the scheme. The criteria for selection and Terms of References (ToR) of TPIAs to be empaneled by the States, is laid down in JJM Operational Guidelines. The details of quality checks done by TPIAs are maintained at State Level.

(d) & (e) As reported by the State of Uttar Pradesh, 7499 Km of pipeline has been laid in Mau district till 27.03.2025. It has also been informed by the state government that 2142 Km of different type of road was dismantled during the work; out of which 2106 Km has already been restored.
