STATUS OF NULM

NO. 5477. SHRI SUDHAKAR SINGH:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:-

- (a) the current status of the National Urban Livelihoods Mission (NULM) along with the number of urban poor benefited from its various schemes since its inception;**
- (b) the details of the funds allocated, released and utilized under NULM for skill development, self-employment and urban poverty alleviation, State-wise;**
- (c) the steps taken/being taken by the Government to ensure effective implementation of NULM, particularly in economically weaker States like Bihar, Jharkhand and Odisha;**
- (d) whether the Government has identified any gaps or challenges in the implementation of NULM and if so, the details thereof along with the corrective measures taken/being taken to improve the efficiency and reach for poor thereof; and**
- (e) the measures taken/being taken by the Government to enhance employment opportunities, promote Self-Help Groups (SHGs) and provide better financial support for microenterprises under NULM?**

ANSWER

- (a): The Ministry of Housing and Urban Affairs, MoHUA implemented Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY-NULM) in 2014 and it ended on 30th September, 2024. The progress of DAY-NULM since its inception until 30th September, 2024 is at Annexure-I.**

(b): Under DAY-NULM, Central Assistance is released to States/ UTs as a whole. The inter-se allocation of funds under different components of the Mission is done by the respective States/ Uts, as per their requirements. The details of funds released and utilized are at Annexure-II.

(c)&(d): The States/Uts effectively implemented the scheme DAY-NULM through their respective Urban Local Bodies (ULBs) comprising various components viz. Self-Employment Programme (SEP), Social Mobilization and Institutional Development (SMID) etc. The Central Government from time to time mentioned the implementation of the scheme through the following measures:

- **Providing help to SHGs for selling their products through various online and offline marketing strategies.**
- **Organising SHG (Self-Help Group) credit linkage melas with banks.**
- **Holding meetings with the State Level Bankers' Committee (SLBC), District Level Bankers' Committee (DLBC), and Block Level Bankers' Committee (BLBC).**
- **Awareness campaigns have been conducted through various IEC activities such as hoardings, banners, pamphlets and electronic & print media.**
- **Review progress of mission with State Level Officers.**

Based on the learnings of DAY-NULM, the pilot was launched with effect from 1st October 2024 initially in 25 select cities and later expanded across the country. The pilot extended till 31st March 2025.

(e): Under the Mission, a one-time Revolving Fund support of Rs. 10,000/- was provided to SHGs, which were functional for a period of 3 months and had at least 70% of members as urban poor. Mission offered interest subvention at the rate over and above the rate of interest of 7% on the bank linkage loans sanctioned to SHGs. An additional 3% interest subvention was provided to women SHGs on timely payment of loans.
