5587. SHRI K C VENUGOPAL:

Will the Minister of Women and Child Development be pleased to state:

- (a) the details of the number of women supported by One Stop Centres (OSCs), State-wise;
- (b) the number of complaints lodged about crimes against women in the country, State-wise;
- (c) the details of funds allocated to OSCs and the percentage of fund utilisation during the past five years, State-wise;
- (d) the details of the staff requirements for OSC across the country along with the actual number of staff currently employed; and
- (e) whether each OSC is administered by a woman, in line with programme requirements?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT
(SHRIMATI SAVITRI THAKUR)

(a): The One Stop Centre (OSC) is a component of Sambal vertical under the Umbrella Mission Shakti. It provides integrated support and assistance under one roof to women affected by violence and those in distress, both in private and public spaces. One Stop Centres (OSCs) have assisted 10.98 lakh women up to 28th February, 2025 since inception of the scheme in 2015.

(b): As per the latest information published by National Crime Records Bureau (NCRB), State/UTs- wise details of cases registered for the crime against women during the years 2020, 2021 and 2022 is at **Annexure- I**.

(c): Details of the funds released to OSCs and percentage of funds utilised by the States/UTs during the last five years are at **Annexure-II**.

(d) and (e): As per the Mission Shakti guidelines, the head of an OSC is a woman administrator. Further, Central Government provides 100% financial assistance to States/ UTs for implementation of OSC scheme for 13 persons which comprises Centre Administrator (1), Case Worker (2), Para Legal Personnel/Lawyer (1), Para Medical Personnel (1), Psycho-social Counsellor (1), Office Assistant with computer knowledge (1), Multi-purpose Staff / Cook (3) and Security Guard/ Night Guard (3) for each OSC. Furthermore, financial assistance is also provided to State & UTs for the establishment of OSCs in either rented premises, pre-existing government buildings, or for construction of new building. The responsibility for the effective implementation and monitoring of the OSC scheme lies with the respective State Governments/UT Administrations to ensure its efficient operation.
