Pending Forest Claims

2749. ADV GOWAAL KAGADA PADAVI:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the number of claims on forest land in Nandurbar Lok Sabha Constituency which have been settled and the details thereof;
- (b) the details of forest claims which are still pending in Nandurbar Lok Sabha Constituency along with the time by which the said claims will be approved;
- (c) the details of total number of claims on forest land which have not been settled in the entire country, State-wise including the State of Maharashtra; and
- (d) whether the Government is taking any steps for the settlement of pending claims on forest land and if so, the details of steps being taken in this regard?

- (a) As per the information received from the State of Maharashtra, the details of the claims under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 in Nandurbar Lok Sabha Constituency is as follows:

- (b) to (d) As per information received from State Government, 1925 number of forest rights claims are pending in Nandurbar Lok Sabha Constituency. The state wise details of individual and community forest rights claims pending in the country are placed at **Annexure-I and II** respectively.

As per the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 and Rules thereunder, responsibility for implementation of

the Act lies with the States/UTs. The Ministry of Tribal Affairs is the nodal Ministry for monitoring the implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The Ministry of Tribal Affairs has issued various guidelines and advisories to the State/ UTs Governments for effective implementation of the Act.
