- (a) whether cases of minting of fake coins have been noticed by the Government;
- (b) if so, the details thereof;
- (c) whether the Government have taken any action in this regards; and
- (d) if so, the details thereof?

Answer

MINISTER OF STATE IN MINISTRY OF FINANCE (SH. BALASAHEB VIKHE PATIL)

(a): A few cases of circulation/manufacture of fake coins have come to notice.

(b) (c) & (d): A state ment indicating the details of the cases is enclosed. 'Public Order' and 'Police' are state subjects under the Constitution to India. As such, registration, investigation, detection and prevention of crime is primarily the responsibility of State Government. However, the Government of India has been advising the State Governments fromtime to time to give more focussed attention to improving the administration of criminal justice system to ensure effective prevention of crime.
