## Answer

(a) & (b) Access to low cost funds from RBI and Government of India enabledFinancial Institutions to extend loans at concessional rates of interest. With the introduction of financial sector reforms, access to long term concessional funds has stopped and Financial Institutions have to raise funds from the market on commercial terms. Hence, they extend financial assistance at market related rates (based on credit worthiness) to all eligible and viable projects of industrial concerns including projects located in backward areas.
