SHORTAGE OF COLD STORAGE

Will the Minister of AGRICULTURE be pleased to state:

- (a) the number of cold storage functioning in the country particularly in Andhra Pradesh, Uttaranchal, Orissa and in the areas where production of Pine-apple, orange, Water-melon etc. are produced in large quantity at present, state-wise;
- (b) whether there is acute shortage of cold storage in the country particularly in those States;
- (c) the number of cold storages set up in the country particularly in those States during 2001-2002 and 2002-2003 till date respectively, State-wise;
- (d) whether the Government propose to set up the new cold storages in the country particularly in those States;
- (e) if so, the details thereof, State-wise; and
- (f) if not, the reasons therefor?

Answer

MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV)

- (a) : A statement indicating number of cold storages in the country as on 31.12.2001 is annexed (Annexure-I).
- (b) The High Level Expert Committee on Cold Storage and Storage in its report submitted, in February 1999, to the Ministry of Agriculture had identified creation/expansion of 12 lakh tonnes during next five years and also to rehabilitate/modernize 8 lakh tonnes of cold storage capacity lying closed. Based on the recommendations of the Committee report the National Horticulture Board (NHB) is implementing a scheme 'Capital Investment Subsidy Scheme for Construction/Expansion/Modernization of cold storages and storages for Horticulture Produce'. Under the scheme additional capacity of 27.37 lakh tonne has since been created with the sanction of 604 cold storage projects.
- (c) A statement indicating number of cold storages set up in the country during 2001-02 and 2002-03 (upto 31.10.2002) is annexed (Annexure-II).
- (d) to (f): The aforesaid NHB scheme assisting creation of cold storage capacity is project based. The entrepreneurs from any part of the country may take advantage of the scheme.
