TWENTY-EIGHTH REPORT

(Presented on 16.5.2007)

I, the Chairman of the Committee on Private Members' Bills and Resolutions, having been authorised by the Committee to present the Report on their behalf, present this Twenty-eighth Report.

2. The Committee met on 14 May, 2007 for the purpose of classification and allocation of time for discussion of Bills under clauses (b) and (c) of Rule 294(1) of the Rules of Procedure.

Classification and allocation of time to Bills

3. The Committee considered classification and allocation of time in respect of fourteen Bills as shown in the Appendices.

4. After considering all aspects of the Bills, the Committee recommend that 9 Bills shown in Appendix-I be placed in category 'A'. The Committee further recommend that the remaining 5 Bills shown in Appendix-II be placed in category 'B'. The Committee also recommend allocation of time for each of the Bills as shown in column 5 of the Appendices I & II, respectively.

Recommendations

5. The Committee recommend that the classification and allocation of time to fourteen Bills by the Committee, as shown in the Appendices, be agreed to by the House
