Title: Need to constitute National Education Commission in the Country.

DR. K.S. MANOJ (ALLEPPEY): Mr. Chairman, Sir, I am sorry I was not present in the House when you called my name because I had an appointment with the hon. Minister of Shipping and Transport at 7.30 p.m. That is why I had to go there.

DR. K.S. MANOJ : [\[r89\]](#)Sir, today, the students of our country, under the auspices of Students Federation of India, observed today as the day for Protection of Education Rights of the Students of the country. They are demanding an institution of a National Commission on Education to look into various aspects of education in our country.

In their demand, they are asking for an assurance for reservation of seats to SC/ST and OBC students in all the professional educational institutions. The UPA Government has agreed to increase the investment in education. In the Eleventh Plan itself, they have agreed to enhance the provision for education. Even though, the UPA Government has announced it, nothing has happened so far. So, the students demand that six per cent of GDP or 10 per cent of the budgeted amount should be provided for education.

Sir, there is no regulation for controlling self-financing professional colleges in our country. The functioning and the admission process in the self-financing professional educational institutions should be regulated and the admission should be based on merit only and the reservation in the educational institutions should be made as early as possible. I would also request that the other demands of the students of the Students Federation of India should be looked into seriously and fulfilled.
