">SHRI SOMNATH CHATTERJEE (BOLPUR): Mr. Speaker, Sir, I wish to humbly associate with what has come from you, from the Chair, deprecating the most unseemly incident that took place on the floor of the House.

Sir, the Leader of the Opposition has rightly reminded us about the decision we took by passing a unanimous resolution in the House about our conduct in this highest forum of our parliamentary democracy. It is a matter of

great sadness that even before the end of the 50th year of Independence celebrations - we are going to hold it on the 15th August, 1998 - such an incident took place. The only solace that I find today is that every section of the House is sincerely condemning that incident, which I also do, on behalf of myself and of my party. We consider this House as not only the highest forum of parliamentary democracy but this is the place where different views, different projections concerning the nation and concerning the parliamentary democracy are exchanged. We exchange each other's ideas and views so that the nation can come to a decision, maybe with a majority of the House. But, here we should not allow passions - whatever may be the nature of things that are being raised - to be raised to that extreme where we use our muscle power within the House.

Sir, I have no words really to express adequately my sadness and anguish at what had taken place inside the House. Let us not try to emulate unseemly incidents wherever it may have taken place. Some hon. Members have also referred to such incidents happening in some other places. Let us not emulate them. Let our House, at least, set the highest standard of parliamentary functioning so that others may get inspiration from this House.

Therefore, Sir, I humbly join in deprecating the incident, condemning the incident. Since unconditional apology has been expressed by the leaders of the respective groups, I may request you, and through you, Sir, the Minister for Parliamentary Affairs, not to proceed with that motion so that the situation may be normalised. Sir, I am sure the Members themselves also feel that what they had done yesterday was not proper. Nothing like this should happen in future in this House.

">SHRI INDRAJIT GUPTA (MIDNAPORE): Yesterday, I was really overcome with anguish and grief at what was happening here. I know that similar incidents had taken place in some of the State Legislatures. But, after all, this is the House of People; it is the Parliament of India; it is the supreme body which is expected to set standards in all respects for all people, for all parties throughout the country. So, I do not recall, in all my thirty and odd years in this House, any similar thing happening in the Lok Sabha.

Yes, proceedings have been held up. That is true. Sometimes, the proceedings have been held up for weeks together. We have been witness to those scenes of people obstructing the proceedings from going on. But what happened yesterday, I think, surpasses all past performances.

I am worried and troubled that if we do not take some salutary measures, this may be only the beginning -- I hope not. I hope, we are not putting our feet on a perilous slope which may lead us to a situation from which it would be very difficult to recover. After all, we have all come here for a certain purpose.

We have come here to debate, to discuss, to argue and to hear each other's arguments and then to decide democratically, if necessary, by majority. If we do not like this procedure then there is no need to come to this House. We can remain outside in the street and settle our disputes in the street. But we do not come here for that purpose.

I am very glad that the two hon. Leaders of the Samajwadi Party and Rashtriya Janata Dal have given their unconditional apologies. Well one leader of the Samajwadi Party has not spoken yet on this particular point, but I am given to understand that he shares the view of the Rashtriya Janata Dal Leader and is willing to express... (Interruptions)

SOME HON. MEMBERS: He has spoken.

SHRI INDRAJIT GUPTA: All right!

But I would have been happier also, if the Members who have been identified as having snatched the papers from the hand of the hon. Speaker and from the hand of the hon. Minister -- they are the Members of this House, after all, and it is all very well to ask their leaders to apologise on their behalf -- had also got up in this House and expressed their own regret... (Interruptions) One or two, I do not know. I was not able to identify, but I read today in the newspapers, two names.

My own suggestion, which I had made earlier this morning but which was not supported by anybody, was that some action should be taken against those Members... (Interruptions) What action is to be taken is for you to decide with the approval of the House. But some hon. Members, some party Leaders have felt that it is not good to take an extreme measure against anybody. This was before we came to know that there was going to be a collective apology. Before that I had made this proposal because I felt that if some measure or some step is not taken, it would amount to a sort of an indirect encouragement of this kind of unruly behaviour and it may lead to worse consequences later on. What will happen to the hon. Speaker, I do not know. Anybody can come and give the hon. Speaker a slap on his face and go away and no action will be taken... (Interruptions) I cannot tolerate this... (Interruptions)

Anyway, when the Leaders have felt that there is no need, just now, for any, what they think would be, extreme measure, so I have not pressed my suggestion. But I am happy that Shri Lalu Prasad and Shri Mulayam Singhji have apologised here unconditionally for what the followers did. I would request once again the followers to search their hearts and their consciences and if they so think fit, they may also add their own voice of apology and regret for what happened.

I hope that the whole House will take a serious lesson from what happened yesterday. Everybody here has condemned without reservation what took place yesterday. Therefore, Sir, I hope that there will be no repetition of this kind of thing again. I offer you not only our cooperation but also my sympathies for what happened yesterday because this is no way to uphold the dignity and the prestige of the Chair. We may not agree with the Chair always but the dignity and the prestige of the Chair is an integral part of our parliamentary democracy. Therefore, Sir, I am happy that nothing further took place; I hope, nothing further of that type will take place. ... (Interruptions)

I can say only one thing. A spirit of intolerance has developed to such an extent that nobody is willing to hear what the other person has to say. ...(Interruptions)

SHRI SOMNATH CHATTERJEE: They want to dictate ...(Interruptions)

SHRI INDRAJIT GUPTA: After all, you are also free to dispute what the other man is saying. You can express your disagreement. You can express your own opinion. Nobody is preventing you. But if you want to prevent people from speaking, you do not want to listen to them and you do not want them to be heard, this kind of thing cannot be tolerated and it will be end of our whole parliamentary democracy.

The other day I was invited by the people from our Bureau of Parliamentary Studies and Training here; others were also invited to go and speak to the newly elected Members. I was told that I should speak to them on the decorum in the House. I politely refused and said: "I am not capable of doing it. I do not know what kind of lecture on decorum I can give. So, I should be pardoned for that."

That is all I have to say. I hope that this will draw a curtain on what has happened yesterday. We can now proceed further along with the path which we were supposed to tread on.

">SHRI I.K. GUJRAL (JALANDHAR): Mr. Speaker, Sir, last night was a very anguishing night for me. I received many number of telephone calls from people who are known to me and unknown to me, who had seen the scene on the Television and conveyed to me, 'do I deserve to sit in such a House?' I do not know how to respond to them. My head hang in shame. In the half a century of our Republic, Sir, Parliament had never witnessed such an indecorum. I think, we have all brought indignity to ourselves and I think, it will take a long time to erase this impression from the public mind that we really are their representatives; not only representing their aspirations but also the dignified ethos of this nation.

We are a civilised nation. People have sent us here with a great deal of hopes. They do wish that we represent them but they also wish that we represent them with dignity and civility. What happened yesterday made me sorry, made me sad beyond doubt and beyond words. I had the opportunity of sitting in this House and in the other House for the best part of my life. I have never witnessed such a scene and I do now know what to say and whom to say. I do not know whether we all deserve this indignity or not.

I hope and pray that all of us, at least at this stage, irrespective of our party affiliations sit down, think for ourselves and promise the electorates once again that we will not let them down.

Give time to all party leaders and then you can ask the Prime minister to come to the House. This is not the way, Sir. You have chosen only a few parties. Give time to all party leaders...(Interruptions).

MR. SPEAKER: Shri Buta Singh, you are a senior Member. Please take your seat.

SHRI BUTA SINGH: This is a matter which concerns the whole House and the whole country. Therefore, give time to all party leaders. Do not give time to Independents like me but give time to party leaders...(Interruptions)

MR. SPEAKER: Nothing will go on record.

श्री जी.एम. बनातवाला : वे माफी भी मांगते हैं, क्रिटिसाईज़ भी करते हैं। यह अच्छी बात नहीं है। इसके लिये भी कुछ किहये।

श्री अटल बिहारी वाजपेयी : मैं आपसे सहमत हूं।

अगर माफ़ी हृदय से है तो सबसे बड़ी सज़ा है। मैं संसदीय कार्य मंत्री से कहूंगा कि उन्होंने जो प्रस्ताव पेश किया है, वह उस पर ज़ोर न दें और सदन आगे कार्र वाई चलाए।
