\*श्रीमती जयश्रीबेन पटेल (महेसाणा): अगले सप्ताह की कार्यवाही में निम्नलिखित विषयों को शामिल करने का कष्ट करें :-

- गुजरात की संजीवनी समान नर्मदा नदी पर बन रहा सरदार सरोवर प्रोजेक्ट फेज-1 के अंतर्गत उसकी ऊंचाई (138.68 मीटर) सेतु एवं दरवाजे के काम बिना मंजूरी के कई वर्षों से लंबित पड़े हैं । अतः केन्द्र सरकार से अनुरोध है कि उपरोक्त काम की मंजूरी शीघ्र बहाल करे ।
- 2. मेरे निर्वाचन क्षेत्र के बहुचराजी, शखलपुर, विसनगर तथा गुजरात के अन्य सभी समपारों की लम्बाई-चौड़ाई के लंबित मामलों को शीघ्र ही मंजूरी दी जाए ।

\*श्री जय प्रकाश अग्रवाल (उत्तर पूर्व दिल्ली): आगामी सप्ताह की कार्यसूची में निम्नांकित विषयों को सिम्मिलित किया जाए :-

- 1. देश में अधिकतर राज्यों में विधान सभा के साथ-साथ विधान परिषद् है, लेकिन कुछेक ऐसे भी राज्य हैं जहां विधान सभा तो है, मगर विधान परिषद् का गठन अब तक नहीं किया गया है । देश के विशेषकर राष्ट्रीय राजधानी क्षेत्र दिल्ली प्रदेश, जहां अब तक विधान परिषद् का गठन नहीं किया गया है, विधान परिषद् की स्थापना किए जाने से संबंधित विषय ।
