*As per schedule, in order to enable Standing Committees to consider Demands for Grants, the House was adjourned on 21.3.1997 to meet again on 21.4.1997.

But following certain political developments the House was re-convened on 11 April, 1997 under the provisions of Rule 15 of the Rules of Procedure and Conduct of Business in Lok Sabha to take up Motion of Confidence to be moved by Shri H.D. Devegowda and after the motion was negatived, House was adjourned *sine die* on that day.

(ii) The House was again re-convened as per provisions of Rule *ibid* from 21 to 23 April, 1997. However, following the adoption of Motion of Confidence in the Council of Ministers moved by Shri I.K. Gujral on 22 April, 1997 itself, the House was adjourned on the same day to meet again on 30 April, 1997.

(iii) Originally the Session was scheduled to conclude on 9 May, 1997. But as per decision taken at the joint meeting of Leaders of Parties/Groups in Lok Sabha and B.A.C. held on 21 April, 1997 the House met from 30 April to 16 May, 1997.
