

**Funds for CSD**

1363. SHRI SATNAM SINGH KAINTH: Will the Minister of DEFENCE be pleased to state:

(a) the quantum of funds released for the Canteen Stores Department (CSD) during each of the last three years and the amount spent by CSD therefrom;

(b) whether any audit of such expenditure was undertaken; and

(c) if so, the shortcomings noticed and the action taken thereon?

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) The quantum of funds, released for the Canteen Stores Department (CSD), during each of the last three years and the amount spent by C.S.D. thereagainst, are as under:—

**Administrative Control of Audit Offices,  
West Bengal**

(d) if so, the details thereof and the date of its implementation?

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) and (b) The post of CDA(EC) was not created to discharge the normal accounting and internal audit functions but to provide services as Integrated Financial Adviser to the GOC-in-C, Eastern Command.

(c) No, Sir.
