INTRODUCTION

- I, Chairperson of the Committee on Papers Laid on the Table of the House (2019-2020), having been authorized by the Committee to present this Report on their behalf, present this Seventh Report in respect of delay in laying of the Annual Reports together with Audited Accounts of the (i) South Zone Cultural Centre (SZCC), Thanjavur; (ii) West Zone Cultural Centre (WZCC), Udaipur (iii) South Central Zone Cultural Centre (SCZCC), Nagpur; (iv) North Central Zone Cultural Centre (NCZCC), Allahabad and (v) North East Zone Cultural Centre (NEZCC), Dimapur.
- 2. In terms of the recommendation of the Committee on Papers Laid on the Table contained in its First Report, Second Report (5th Lok Sabha) and Second Report (6th Lok Sabha) presented to the House on 08 March 1976; 12 May 1976 and 22 December 1977 respectively, the Annual Report and Audited Accounts of the Organisation/Company are required to be laid on the Table of the House within nine months of the closure of Accounting Year.
- 3. The Committee considered the matter of delays in laying of the Annual Reports and Audited Accounts of the above mentioned Zonal Cultural Centres and took oral evidence of the representatives of the Ministry of Culture in this regard in their sitting held on 16th August, 2016.

The Committee considered and adopted this Report at their sitting held on 04.03.2020.

- 5. The Committee wish to express their thanks to the officers of the Ministry of Culture for furnishing the written replies, other material/information and for placing their views in the matter before the Committee.
- 6. The Observations / Recommendations of the Committee have been printed in bold letters at the end of the Report.

Delay in laying of the Annual Reports and Audited Accounts (i) South Zone Cultural Centre (SZCC), Thanjavur.; (ii) West Zone Cultural Centre (WZCC), Udaipur (iii) South Central Zone Cultural Centre (SCZCC), Nagpur; (iv) North Central Zone Cultural Centre (NCZCC), Allahabad and (v) North East Zone Cultural Centre (NEZCC), Dimapur

* * *

The Zonal Cultural Centres (ZCCs) were established in 1986, as autonomous bodies, under the Ministry of Culture, Government of India with the objective of creative development of Indian culture in the different regions and for building up a sense of cultural integration and national unity in the country. The ZCCs aims to preserve, promote and disseminate the indigenous culture, art and heritage of the respective zones through various programmes like Folk Festivals, Tribal, Classical, Theatre, and other art forms, Handicraft exhibition, Workshops and Seminars in Painting, Sculpture etc., Training Programmes, Literary programmes, Documentation of rare art forms etc.

- 2. In terms of the recommendation of the Committee on Papers Laid on the Table contained in its First Report, Second Report (5th Lok Sabha) and Second Report (6th Lok Sabha) presented to the House on 08 March 1976; 12 May 1976 and 22 December 1977 respectively, the Annual Report and Audited Accounts of the Organisation/Company are required to be laid on the Table of the House within nine months of the closure of Accounting Year.
- 3. As per Rule 237 of the General Financial Rules, 2017, the Annual Report and Audited accounts are supposed to be laid on the Table of both Houses of Parliament within nine months of the closure of the respective financial year.
- 4. The ZCCs are financed by the funds provided by the Ministry of Culture. The statement showing the amount of Grant-in-aid received by the ZCCs for the years 2012-13 to 2014-15 is provided at **Annexure-I.**

- 5. The Committee examined the reasons for delay in laying of Annual Reports and Audited Accounts of these five Zonal Cultural Centres namely, South Zone Cultural Centre (SZCC), Thanjavur; West Zone Cultural Centre (WZCC), Udaipur; South Central Zone Cultural Centre (SCZCC), Nagpur; North Central Zone Cultural Centre (NCZCC), Allahabad and North East Zone Cultural Centre (NEZCC), Dimapur, for the year 2014-15 wherein the delay varied between 07 to 11 months.
- 6. From the scrutiny of the written submission of the Ministry of Culture dated 10.08.2016, it is seen that between 2012-13 to 2014-15, out of 15 instances, on four instances only, the reports were laid on time i.e., of WZCC, Udaipur for the years 2012-13 and 2013-14; and of SZCC, Thanjavur and NEZCC, Dimapur, both, for the year 2013-14. Laying of the documents for remaining 11 instances was delayed. The statement showing updated status of laying of the Annual Reports/Audited Accounts of these ZCCs is at **Annexure-II.**
- 7. The chronological sequence showing various stages involved in finalization of Annual Reports and Audited Accounts of these five ZCCs and the time taken in each stage for the period under examination by the Committee is appended at **Annexure-III**.
- 8. The Ministry of Culture in its written submission dated has submitted the following reasons for delay in laying of the Annual Reports and Audited Accounts of the ZCCs for the years mentioned above:

(i) South Zone Cultural Centre (SZCC), Thanjavur

"The South Zone Cultural Centre was running without regular Director from 21.06.2010 to 23.01.2013. Thus the meetings of the Governing Body and other Committees could not be held and consequently the auditing process got delayed. A regular Director was appointed from 24.01.2013 and the Annual Reports of 2010-11, 2011-12 and 2012 -13 got prepared after its approval by the Governing Body and subsequent auditing and issuance of Certificate of auditing by the CAG. Since the audit of the Centre by CAG was not taken up for the previous 3 years mentioned above. CAG conducted auditing of the Accounts in Chronology i.e. 2010-11, 2011-12 and 2012-13.

- **2012-13** -Auditing of accounts of 2012-13 was conducted by CAG in February 2014 and the Report was received in April 2014 and the same was submitted to the Ministry in May 2014.
- 2013-14 -Annual Report for the year 2013-14 was submitted on time.
- **2014-15** -Translation of the Report in Hindi got delayed and the report could only be sent to Ministry by January 2016."

(ii) West Zone Cultural Centre (WZCC), Udaipur

"There was no delay in laying of documents for the year 2012-13 and 2013-14. The Report for the year 2014-15 could not be laid in Parliament within the stipulated time due to procedural and administrative delays which were beyond the control of the Ministry."

(iii) South Central Zone Cultural Centre (SCZCC), Nagpur

"Annual Reports for the year 2012-13, 2013-14 and 2014-15 could not be laid in Parliament within nine months of the close of the Financial year due to some procedural and administrative delays which were beyond the control of the organization."

(iv) North Central Zone Cultural Centre (NCZCC), Allahabad

"Due to large number of programmes organized throughout the year, the staff including that of Accounts department has to be involved resulting in delay in finalization of accounts. Moreover, dates of holding the meetings of the Finance Committee, Executive Board and Governing Body are not generally finalized due to incomplete quorum.

So, while all efforts are made to ensure that the Annual Report is laid in Parliament in time, the delays in laying the Reports are deeply regretted."

(v) North East Zone Cultural Centre (NEZCC), Dimapur

"Annual Report for the year 2012-13 could not be laid within the stipulated time as Rajya Sabha was adjourned sine die. The Report for 2013-14 was laid in time. Annual Report for the year 2014-15 could not be laid well within the time due to some procedural and administrative delays."

9. The Committee was apprised the all the ZCCs have an internal audit mechanism to ensure timely compilation of accounts and also to minimize the audit queries at the time of auditing.

10. As regards streamlining the process of time schedule giving targets dates for completion of work at each stage regarding finalization of Annual Reports and Audited Accounts, the Ministry in their written note have submitted as under:-

11. On the question as to whether any mechanism is in place in the Ministry to monitor the progress of work and to ensure timely laying of the documents, and also whether any remedial measure has been taken or proposed to be taken by the Ministry/ZCCs in this regard, the Ministry in their written reply stated as under:-

"Besides the time schedule set up by the MoC, it has also been mentioned in the Memorandum of Understanding signed between MoC and ZCCs that the Audited Accounts and Annual Report for the closed Financial Year should be submitted to the Ministry by November to enable the MoC to lay the report within nine months of the close of the accounting year. In addition, the administrative division of the Ministry also reminds the organization from time to time."

- 12. The Committee considered the matter of delays in laying of the Annual Reports and Audited Accounts of these five ZCCs during the years 2012-13 to 2014-15 and took evidence of the representatives of the Ministry of Culture and the ZCCs, on the issue on 11th August, 2016.
- 13. During the evidence, the Secretary to Ministry of Culture, regretted the delays on the part of the Zonal Culture Centres and stated that the time taken getting approval of the documents by the Competent Authority, the process of audit of accounts by CAG and Hindi translation of documents were amongst the reasons for the delay.
- 14. The Committee, however, noted that for the year 2017-18, the Annual Reports and Audited Accounts of these five ZCCs were not laid before the Parliament within the stipulated time of 31st December, 2018. Out of these five, four ZCCs have laid the requisite documents before the Parliament with a delay of 01 to 07 months. Whereas, NCZCC Allahabad has failed to lay the documents before the Parliament, for the year 2017-18, till date. Further, these five ZCCs have not laid the requisite documents for the year 2018-19, as yet.

Observations/ Recommendations

- 15. During examination of the delay in laying of the Annual Reports and Audited Accounts of the five ZCCs i.e., (i) South Zone Cultural Centre (SZCC), Thanjavur.; (ii) West Zone Cultural Centre (WZCC), Udaipur (iii) South Central Zone Cultural Centre (SCZCC), Nagpur; (iv) North Central Zone Cultural Centre (NCZCC), Allahabad and (v) North East Zone Cultural Centre (NEZCC), Dimapur for the period 2012-2013 to 2014-2015, the Committee observed that on four instances i.e., WZCC, Udaipur for the years 2012-13 and 2013-14; and SZCC, Thanjavur and NEZCC, Dimapur, both, for the year 2013-14, the documents were laid on time. Even in the subsequent years i.e., 2015-16 to 2017-18, with the exception of WZCC Udaipur for the year 2016-17, the documents of the five ZCCs were laid with further delays ranging between 01 to 19 months. Further, NCZCC Allahabad has failed to lay the documents for the year 2017-18*, till date. The documents for the year 2018-19 have not been laid as yet, by any of these five ZCCs.
- 16. The Committee note that at SZCC, Thanjavur, between June 2010 and Januay 2013, the meeting of Executive board, Governing body etc could not be held in absence of a Regular director which delayed the finalization and submission of audited accounts to the audit authorities and subsequent approval of both the Annual Report and Audited Accounts for the year 2010-11 to 2012-13. The committee opines that the Ministry should either have timely appointed a new Director or should have delegated such powers and duties to a senior official to allow smooth functioning of the SZCC.

Further, the committee note that the delay in laying of the documents for the year 2014-15 was due to delay in translation of report in Hindi, though no such delay in the preceding years occurred on this account. The Committee also note that an expert in Hindi has been engaged by the SZCC to look after the translation work. The Committee hope that no delay will take place, in future, on account of Translation of documents.

17. The Committee note with concern that the Annual Report and Audited Accounts of WZCC, Udaipur for the year 2014-15 were delayed due to certain procedural and administrative reasons. The committee further note that the Ministry took more than 12 months in processing and laying of the documents on the Table of the House for the year 2014-15.

The committee would also like to be apprised of the specific reasons of the procedural and administrative delay during the year 2014-15 as mentioned by the Ministry.

18. The Committee note that besides certain unavoidable circumstances, procedural and administrative delays, and non-receipt of final audit report from audit authorities were also identified as the reason for delays at SCZCC, Nagpur.

The Committee further note that during the year under examination the major reason for delay in the year 2014-15 was due to the time taken in compilation and submission of accounts to the audit authorities. The committee directs the Ministry/SZCC to evolve a mechanism in order to avoid the procedural and administrative delay. The Committee also urge the Ministry/ZCCs to take up the matter of delay in audit process with the office of CAG at the highest level to ensure timely receipt of documents from the audit authorities.

19. The Committee note with concern, the reply submitted by the Ministry that the work related to preparation, finalization and approval of Annual Report and Audited Accounts of NCZCC, Allahabad was delayed due to engagement of staff, including that of accounts department, in organizing the programmes of the NCZCC. The Committee urge that the proper planning of programmes for NCZCC needs to be organized and to keep in mind, to avoid deployment of the staff of Accounts department in organizing programmes and other miscellaneous work so that the accounts work may not suffer in future.

20. The Committee is not convinced with the reply of the Ministry/ NEZCC Dimapur that the laying of documents for the year 2012-13 was delayed as the Rajya Sabha was adjourned sine die. Further, the delay in the year 2014-15 was accounted to delay in obtaining approval for submission of accounts to the auditors. On the contrary, the Committee noted that the actual delay in 2014-15 was due to excessive time taken in compilation of accounts. The Ministry also failed to furnish the details of time taken by them in processing of documents before laying them before the Parliament.

The Committee feel that the delay could have been avoided if the accounting system was computerized at NEZCC. The Committee recommends the Ministry/NEZCC to take immediate steps to computerize the accounting system at the NEZCC.

- 21. The Committee is of the considered view that despite the Time schedule drawn by the Ministry and also an MoU signed between Ministry and ZCCs for timely laying of requisite documents before the Parliament both the ZCC and the Ministry failed to adhere to them. The Committee, therefore, recommends the Ministry and the ZCCs to take adequate steps to adhere to the schedule/MoU to ensure timely laying of documents.
- 22. The Committee impress upon that if due to unavoidable reasons, the Annual Reports and Audited Accounts of the ZCCs could not be laid on the Table of the House within stipulated time, a statement explaining the reasons as to why the requisite documents could not be laid within prescribed period should be laid on the Table of the House strictly within 30 days as recommended by the Committee in its earlier reports.
