CHAPTER - I

PUBLIC ACCOUNTS COMMITTEE

I. Election and Composition

The Public Accounts Committee for the year 2019-20 was constituted *w.e.f.* 24thJuly, 2019. It consisted of fifteen Members from Lok Sabha and seven Members from Rajya Sabha elected from amongst the Members of the respective Houses. The term of the Committee ended on 30th April, 2020.

- **1.2.** Shri Adhir Ranjan Chowdhury, MP (LS) and a Member of the Committee was appointed as Chairperson by the Speaker *vide* Bulletin Part II No. 402 dated 25th July, 2019. The composition of the Committee (2019-20) is given at **Appendix-I**.
- **1.3.** One Member, Shri P. Bhattacharya from Rajya Sabha was elected as Member of the Committee w.e.f.10th February, 2020 *in lieu* of vacancy caused due to resignation of Shri Bhubaneswar Kalita from Rajya Sabha on 5th August, 2019.

II. Subjects selected for examination

1.4. The Public Accounts Committee, at their sitting held on 26th August, 2019, selected 107 subjects/Audit paragraphs (*vide* Bulletin Part-II No. 517 dated 28th August, 2019) for examination during 2019-20. A Press Release dated 29th August, 2019 was issued indicating priority accorded to 23 subjects selected for examination during 2019-20. The subjects selected for in-depth examination at the sitting held on 26th August, 2019 *inter-alia* included Para Nos. 1.6, 4.1, 4.7 and Chapter Nos. II and III from CAG Report No. 11 of 2019. Instead of selective examination of the Paras/Chapters from the Report, the Committee at their sitting held on 19th November, 2019, selected the entire CAG Report No. 11 of 2019 for in-depth examination during 2019-20. The Committee selected eight additional subjects during their sitting held on 27th December, 2019 which were notified *vide* Bulletin Part-II No. 1093 dated 31st January, 2020. Thus, a total number of 111 subjects were selected by the Committee for examination during 2019-20. The details of these subjects are indicated at **Appendix-II**.

III. Constitution of Sub-Committees

1.5. Three Sub-Committees of the Public Accounts Committee were constituted to examine the subjects allocated to them during the term 2019-20. The Constitution of the Sub-Committees-I, II and III alongwith the subject allocated to each Sub-Committee was notified *vide* Bulletin Part-II No.925 dated 18th December,2019. The composition of the Sub-Committees are given at **Appendix-III**. These Sub-Committees were entrusted with the work of examination of the following specific subject as indicated against each of them:

Subjects allocated to the Sub-Committees for examination during 2019-20

(i) Sub-Committee - I

Subject: Report No. 8 of 2019 – Preparedness for the Implementation of Sustainable Development Goals (SDGs)

(ii) Sub-Committee – II

Subject: Report No. 37 of 2017 – Implementation of Food Safety and Standards Act, 2006

(iii) Sub-Committee - III

Subject: Report No. 12 of 2017, Chapter XVI, 16.1 – Implementation of Prime Minister's Employment Generation Programme (PMEGP)

IV. Review of Work Done

(a) Sittings of the Committee/Sub-Committees

1.6. During the period under review,17 sittings (14 sittings of the Main Committee and 3 sittings of the Sub-Committees) were held. The total duration of these sittings was 26 hours and 55 minutes, the break-up being 22 hours and 40 minutes of Main Committee and 04 hours 15 minutes of the Sub-Committees. A statement showing details of the dates and duration of each sitting, the number of Members present and subjects discussed in the Main Committee is given at Appendix-IV. Similarly, the details of the dates and duration of sittings of the Sub-Committees are given at Appendix-V. Another

statement showing details of the number of sittings of the Committee attended by each Member is given at Appendix-VI.

(b) Examination of Appropriation Accounts and Audit Reports.

1.7. In the course of examination of Accounts and Audit Reports, the Public Accounts Committee studied the relevant material on various paragraphs contained in the Reports of the C&AG of India, besides undertaking examination of four Appropriation Accounts of the Union Government for the year 2017-18, relating to Civil, Postal Services, Defence Services and Railways. Further, a Press Communiqué dated 25th November, 2019 was issued in leading Newspapers of the country inviting views/suggestions on the subject "Goods and Services Tax" from Stakeholders/Industry Representatives/ Experts/ Institutions/ Organisations interested in the subject.

(c) Visit for on-the-spot study

1.8. The PAC (2019-20) undertook three on-the-spot study visits to have first hand information about the functioning of various Government establishments/Departments/organizations. The organizations/places visited by the Committee during the period are indicated at **Appendix-VII**.

(d) Proceedings & Minutes

1.9. The verbatim proceedings of the Sittings containing evidence tendered by the witnesses before the Committee were kept on record. The Minutes of the sittings of the Committee were prepared and presented to the House along with the Reports concerned.

V. Reports Finalised and Presented

1.10. The Committee finalised and presented 15 Reports in total (6 Original Reports and 9 Action Taken Reports) to the House during the period under review i.e., 2019-20.

1.13 Action Taken Statements

Besides the above mentioned 6 Original and 9 Action Taken Reports which were presented to the House, one Statement of Final Action Taken Notes on 121st Report on Action Taken by the Ministry on the Observations/ Recommendations contained in the 94th Report (16th Lok Sabha) of the Committee was also laid on the Table of both the Houses.

VI. Secretariat

- 1.14 The Public Accounts Committee Branch functions as the Secretariat of the Committee. An Additional Secretary/Joint Secretary, one Director, three Additional Directors and two Deputy Secretaries supervised the functioning of the Branch. Additional Secretary/Joint Secretary remained overall in-charge of the Committee Secretariat.
- 1.15. During the year 2019-20, the Secretariat examined four Appropriation Accounts of the Union Government for the year 2017-18 and also, undertook an exhaustive study of the Audit Reports/Paragraphs and the Memoranda of Important Points as furnished by the Office of the Comptroller and Auditor General of India apart from going through other relevant materials such as Press Clippings, Websites, Questions/Debates in Parliament, literature and publications on the subjects, etc. Based on the studies so conducted, the Secretariat framed questionnaires for eliciting further information from the Ministries/Departments concerned. After approval, these questionnaires were sent to the Ministries/Departments concerned for obtaining replies. Based on the replies received, the lines for enquiries by the Committee during evidence were suggested to the Members of the Committee in the form of List of Points. The verbatim proceedings of the evidence were subsequently studied by the Secretariat and post evidence questionnaires were sent to the Ministries/Departments concerned for elucidation and elaboration of points arising out of evidence.
- 1.16. The Secretariat undertook an in-depth study of all the materials relating to the subjects under examination including background notes, advance information, material from Parliamentary debates and verbatim proceedings, the replies to the questions raised subsequent to evidence and inputs gathered from the field visits. The material so gathered ran into approximately 20,000 pages. Thereafter, relevant points/issues were culled out of the material gathered and Reports were drafted and submitted to the Chairperson of the Committee. After approval of submitted Reports, gist of the Reports was prepared and placed for perusal of Hon'ble Speaker, Lok Sabha before being placed for adoption by the Committee. These Reports were circulated among the

Members of the Committee for their consideration and adoption by the Committee during their Sitting held for the same.

- 1.17. Consequent upon the presentation of the Reports, copies thereof were forwarded to the Ministries/Departments concerned with the request to furnish requisite number of Action Taken Notes/Replies on the Observations/Recommendations contained in the Reports. After the receipt of the Action Taken Notes/Replies, the Secretariat processed them and prepared Action Taken Reports and categorized the replies according to the prescribed pattern. The draft Action Taken Reports were thereafter submitted to the Chairperson for approval. After being approved by the Chairperson, gist of the Reports was prepared and placed for perusal of Hon'ble Speaker, Lok Sabha before being placed for adoption by the Committee. These Reports were circulated among the Members of the Committee for their consideration and adoption by the Committee during their Sitting held for the same. The Action Taken Reports so adopted were of Parliament and forwarded to both the Houses Ministries/Departments concerned for furnishing final Action Taken Notes/Replies on the Observations/Recommendations contained therein.
- 1.18. The Secretariat also uploaded all the Reports presented to the House on the APMS (Audit Para Monitoring System) portal where the Ministries/ Departments concerned are also required to upload their Action Taken Replies on the recommendations/ observations of the Committee and the remedial/corrective Action Taken Notes on all the Audit paras contained in the various C&AG Reports, pertaining to the Union Government, referred to the Committee.
- 1.19. Besides, the Parliamentary Questions received from Question Branch, information sought by the Committee Coordination Branch and RTI applications received from Information Cell were also attended to by the Secretariat. Numerous representations addressed/endorsed to Chairperson, PAC were also processed by the Secretariat and followed to their logical conclusion.

1.20. Thus, the Secretariat dealt with the study of all the relevant materials, preparation of Questionnaires/List of Points, drafting of Reports and their presentation, printing, circulation etc., besides performing other related and routine work of the Committee.
