THE MINISTER OF ENERGY (SHR) A. B. A. GHANI KHAN CHAUDHURI): Sir, I am glad to inform the Hon'ble Members that there has been considerable improvement in power generation in the county. The energy generation target of 1,22,000 million units during the year 1981-82 will not only be achieved, but also be exceeded. The thermal generation has registered an increase of 13.4 per cent as compared to 1980-81 with the improvement in capacity utilisation from 45 per cent during 1980-81 to 47 per cent during 1981-82. The increase in generation has considerably brought down the power shortage in the country from 16.1 per cent in 1979-80 to 10.6 per cent during April, 1981 to February, 1982.

The improved availability of power in the country has facilitated increase in industrial production during 1981-82 to the extent of 8 per cent as against 4 per cent during 1980-81. Production in the core sectors like steel, coal, etc., have also considerably increased during 1981-82 as a result of the improved availability of power in the country. Despite early withdrawal of South-West Monsoon in the Western Region of the country, Kharif production of about 80 Million could be achieved compared with 77.4 Million Tonnes in 1980-81. This achievement has mainly been due to concerted efforts made by the Ministry of Energy and the States concerned to make available adequate power to the agricultural consumers in the various States
