Expenditure in Foreign Exchange on Minister's Visit Abroad

SOREN: Will 4000. SHRI SHIBU the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) whether he went to Geneva in the month of June, 1981;

(b) what is the detailed description of the same;

(c) how much expenditure was incurred on this trip in Indian and foreign currency;

(d) whether he made foreign visits to some other countries also during 1980-81 and what are the total expenses incurred in foreign exchange: and

(e) whether Government are taking some steps to improve the diminishing foreign exchange position?

MINISTER OF TOURISM THE AND CIVIL AVIATION (SHRI A. P. SHARMA): Yes. Sir.

(b) Department of Tourism have operating for some years now integrated programmes between Air India and the Regional Offices of the D. G. (Tourism) abroad under the name of "Operations Europe, Australasia, etc." for promoting international tourism to India. Periodical reviews of the performance of these schemes are undertaken. The Minister for Tourism & Civil Aviation held one such review meeting on 'Operation Europe' in Geneva on 15-6-81. The Swiss Government hosted the Minister on 16th and 17th June, 1981 and showed him the tourist facilities developed by that country for promotion of tourism.

(c) Rs. 27,327 in Indian currency and foreign exchange Rs. 16,632 (estimated).

(d) Yes, Sir. The total foreign exchange involved o the visits abroad in the year 1980-81 was Rs. 10,793 (estimated).

(e) Tourism is one of the major earners of foreign exchange for the country and hence every effort is made to increase international tourist traffic to India, so as to increase our foreign exchange earnings. The review of "Operation" is part of our effort to build up tourist traffice to India.
