STATEMENT RE: INCLUSION OF SHOLAPUR DIVISION IN CENTRAL RAILWAY

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): Sir, the H use will recall that ever since the information of South Central Railway in October, 1966, there have been persistent demands for the transfer of Sholapur Division back to the Central Railway both from the public as well as the Railwaymen.

Representations have been received from time to time amongst others from M.Ps., M.L.As. local bodies and Unions highlighting the difficulties faced by the rail users including traders and industrialists as well a railway staff on Sholapur Division. Questions have also been asked in both the Houses from time to time regarding transfer of Sholapur Division back to the Central Railway.

AUGUST 6, 1977 Employment of 36 SC/ST & Commr. Reports (Disc. & Motion)

A Committee comprising of 3 Members of Parliament under the Chairm nihip of the then Dy. Minister of Railways was constituted to indentify and examine the problems of Sholapur Division.
