

It is so in oil seeds, oil and also in pulses. These are the commodities which are having the seasonal production, which cannot be dealt with now because substitutes are not available.

MR. CHAIRMAN: Prof. Amin, you can continue tomorrow.

SHRI KANWAR LAL GUPTA: Sir, I want to know whether it will be taken up tomorrow.

SHRI MOHAN DHARIA: Sir, I will have to see when it will be included in the agenda. I am sure tomorrow it will not be included in the agenda.

SHRI KANWAR LAL GUPTA: Why not tomorrow?

MR. CHAIRMAN: We do not know what will be the tomorrow's agenda.

SHRI KANWAR LAL GUPTA: Four hours are allotted for this purpose. Two hours are over and two hours are still there. Let us take the consensus of the House.

MR. CHAIRMAN: I understand that tomorrow's agenda has already been announced. But anyhow it will be taken up.

SHRI KANWAR LAL GUPTA: For instance, yesterday the censure motion was not over and it was taken up today, though there was no censure motion scheduled for today. Similarly, we can have a discussion for two hours tomorrow. Let us take the opinion of the House.

PROF. P. G. MAVALANKAR (Gandhinagar): Four hours had been allotted; two hours had been utilised and two hours remain. My point is that two hours must be found either tomorrow or on Monday, within this session; it cannot be indefinite; this resolution cannot go on to the next session. By that time prices may rise further.

MR. CHAIRMAN: Your suggestions will be considered by the hon. Speaker.

SHRI MOHAN DHARIA: Tomorrow there is the discussion on the reports of the Scheduled Castes and Scheduled Tribes; let us not disturb that discussion. This should be taken up on Monday; this should be conveyed to the hon. Speaker.

SHRI KANWAR LAL GUPTA: The White Paper has to be discussed on Monday. I am really sorry.

SHRI P. K. DEO (Kalahandi): We can sit till midnight.

MR. CHAIRMAN: You are encroaching on Mr. P.K. Deo's time now. Your suggestions will be considered by the hon. Speaker and he will take a decision.

PROF. P. G. MAVALANKAR: Leaving everything to Monday would bring us difficulties; Monday is already full. Tomorrow we can sit longer, after that other debate is over.

SHRI MOHAN DHARIA: Tomorrow after that debate is over, we can sit. Please take it up with the Speaker.

SHRI KANWAR LAL GUPTA: Tomorrow after the discussion on Scheduled Castes and Tribes is over at 6 p.m. or 7 p.m. we can take this up. That is the decision of the House.

MR. CHAIRMAN: I shall convey it.
