SHRI JYOTIRMOY BOSU (Diamond Harbour): Sir, on Item No. 2. sub-item (1), sub-sub-item (i), (ii) (iii) and (iv), the Monopolies Restrictive Trade Practices Act, 1969 clearly lays down that the Central Government shall cause to be laid before both Houses of Parliament an Annual Report and every Report which would be submitted to it by the Commission from time to time pertaining to the execution of provisions of this Act.

Sir, I would like the hon. Minister to tender an explanation before this House as to why all the Reports that have been given already have not been laid on the Table of the House. Number one. Then, number two is this. Why was the English version of the Report laid on the Table on 26th March, 1974, and why is Hindi version being laid now, Sir? Why, from 1974 to 1978, this long gap? I know it relates to the erstwh**ile** Government, but this Government should tell the House, this should be taken into confidence to what was the reason.

Sir, the Reports under the Monopolies and Restrictive Trade Practices Act, which are always against the big houses like Hindustan Lever, Rallis India Ltd., Wimco Limited, etc. were withheld deliberately to keep the House in darkness, to allow Monopolists and the Multi-nationals to continue with the loot. Sir, I want an explanation

MR. SPEAKER: You mentioned that.

SHRI JYOTIRMOY BOSU: No. Sir. The Minister must enlighten us on how many reports have been laid on the table of the House.

MR. SPEAKER: He says all the reports (Interruptions).
