THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI SHANTI BHUSHAN): Mr. Deputy-Speaker, Sir, on the last date when I was intervening, I had said that I was in agreement with Shri Mavalankar when he had said that there was a stage when a country could make a provision for the right to work and unemployment relief and that stage has to be when the unemployment problem had been solved basically, so that there would be a few unemployed persons, who would be entitled to unemployment relief on account of the fact that for some reason, it was not possible to give them employment for a certain period.
