[Shrimati Parvathi Krishnan] ment made by the Prime Minister and the decision taken to have the judicial enquiry into the incidents at Agra and I conveyed to him also the sentiments of the whole House as expressed this morning including the personal sentiments of Shri Vajpayee. I am happy to tell you that he wished me to convey to the House the fact that he appreciated very much the very prompt manner in which the Prime Minister has intervened in the matter. He wished me to convey his deep appreciation of all the support that has been given to him from all corners of the House this morning and in view of the fact his request has been granted, he has taken the decision to withdraw his hunger strike.

FLOODS IN UP, ASSAM AND BIHAR-Contd.

THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): I had covered the first question raised by the hon, member.

दूसरा सवाल या कि स्टडी टीम भेजनी चाहिए। स्टडी टीम उन प्रांतः में भेजी जाती है, जहां बाढ़ ग्राती है।

[MR. DEPUTY-SPEAKER in the Chair]

जहां अहां से भी मांग धाती है कि स्टडी टीम भेजी जाए, वहां स्टडी टीम भेज वी जाती है ताकि जो कुछ उस प्रान्त में हुआ है। उसका एसेसमेंट किया जा सकी घीर उस एसेसमेंट के बाद धगर कोई मुनासिब कार्यवाही करने वालीहो, मदद देने वाली हो, वह दी जा सके। हमें जहां से भी ऐसी मांग झाएगी, वहां पर स्टडी टीम भेजी जायेंगी, इसमें कोई दुविषा की वात नहीं होनी चाहिए।

माननीय सदस्य ने कहा है कि गंगा कमीशन का दक्तर पटना से लखनक ले जाना माहिए। उन्होंने कोई बहुत दलील तो नहीं दी है कि उसको क्यों लखनऊ ले आया जाए। पटना गंगा दरिया के ऊत्पर है धीर एक इम्पार्टेट जगह है---इम्पार्टेंट तो लखनऊ भी है,-लेकिन पटना सैंट्रस प्लेस है। इस दरिया के जरिये यू० पी०, बिहार भीर वैस्ट वंगाल में बाढ़ भाती है भौर उन तीनों स्टेटस में फ्लड-कन्टोल का काम होता है। उसके लिये पटना एक सैंट्रल प्लेस है भीर इसलिए वहीं यह दफ्तर बना हुआ है। भगर इस दफ्तर को वहां से शिषट किया जाएगा, तो पटना वालों को दिवकत होगी भीर वे एतराज करेंगे। इसलिए इस दफ्तर को वहीं रखा जाना चाहिए।

भो उम्रसेन : मैंने शिफ्ट करने की बात नहीं कही है। मैंने कहा है कि उसका एक सब-माफिस खोला अरए ।

भी सरकीत सिंह बरनाला : माननीय सदस्य ने ड्रेजर इस्तेमाल करने की बात भी कही, जिससे शायद कुछ क्लड-कन्ट्रोल हो सके। मैं बताना चाहता हं कि ड्रेजर का काम बहत ज्यादा कीमत पर होता है। यह पोट्सं वरीरह छोटी जगहों में ड्रेजिंग करने के लिए इस्तेमाल होता है। जैस, कलकता में हगली दरिया को हेज करने के लिए कांटीन्यएसली हेजर का इस्तेमाल किया जाता है। सभी हम ब्रह्मपुत्र में दो डेजर लेकर गये थे, जिनमें से एक को इस्तेमाल कर के देखा है। उसका कोई प्रच्छा नतीजा नहीं निकला है। जितना इजिंग होता है, उतनी मिट्टी घीर मा जाती हैं और हर साल सिल्टेशन बढ़ जाता है। उससे कोई लाभ नहीं हो सका है। हमारे पास ऐसी कोई इसिला नहीं है कि दुनियां में कहीं किसी बहुत लम्बे दरिया में ड्रेजिंग का काम किया गया हो । हां, छोटी छोटी अगहों में--अहां बन्द बनाना हो, मिट्टी हटानी हो---उससे काम लिया जाता है।

SHRI JANARDHANA POOJARY (Mangalore): Sir, we have heard the sorrowful saga of the flood-affected people of UP, Bihar, Assam and other parts of the country. But as you know, from 1958 onwards upto 1976, about 29 High-level Committees have been appointed. They have been set up to find out ways and means of having an effective control over the floods but no action has been taken. I agree with the sentiments expressed by Shri Ugra Sen but I feel that the Minister has made the statement in a casual manner. It appears that nobody is serious about this flood situation. You just imagine the condition of about 10 lakhs of people in UP who are affected by the floods and nearly 1,000 villages which marooned. Still, we feel no serious action has been taken by the Minister. I also feel Sir, that there is nobody to wipe the tears of the people. I also support the views expressed by Shri Ugra Sen about the sentiments of the people and about the grievances of the people of U.P. Bihar, Assam and other parts of the country.

As you know, as per the latest press reports as also the news over the radio, we have heard that number of villages are marooned. Lakhs of people are affected. Under these circumstances I want to know whether any relief work has been undertaken. Even if the relief work is there, is the operation being done on a war footing? What are the relief works undertaken by the Government? Is the Government going to direct the State Government to suspend the realisation of the land revenue? What are the immediate, short-term and the long-term measures which the Government is going to take to control the floods?

SHRI SURJIT SINGH BARNALA: Sir, so far as the flood situation is concerned, I have already mentioned all the details about the marooned villages, about the number of villages affected, about the number of areas

affected, the number of population affected, etc. All those details have been given by me.

The only question that has been asked by the hon. Member is this:

He asked: What relief works are we going to arrange?

Now, relief works generally are being arranged by the State Governments. If they want any assistance from us in any areas, for example, if they want us to send them some supplies of a particular item we do it. If they want wheat or some rice in some area, we shall supply it.

Last year, for example, we supply baked bread to some villages where the villagers were marooned. That was taken by the helicopter and dropped. Some camps—health campas—first-aid etc., were also organised. Wherever they asked us for any assistance, we shall be glad to provide that. The work of evacuation is going on and boats have been sent to those villages. Military was also called in some areas. The work is going on.
