

(c) The following broad guidelines are kept in view for selecting feature films for import:

1. The film should provide good, healthy and wholesome entertainment to the public.
2. Films, the thematic content of which may have the effect of undermining our national institution and our value system should not be imported, even if they are otherwise of good quality and not objectionable from the Censor's point of view.
3. The films imported should be of high quality both technically and in terms of the cinematic art.
4. They should not depict violence, nudity or sex.
5. They should contribute to the healthy development of the public taste and the promotion of goodwill and harmony among all sections of the people and among peoples of different countries.
