CALLING ATTENTION TO MATTER OF URGENT PUBLIC IMPORTANCE

BANGLADESE GOVERNMENTS PRE-CON-DITION FOR TALKS ON SHARING OF GANGA WATERS

SHRI SAMAR MUKHERILE (Flow-I call the attention of the Minister of External Affairs o the following matter of urgent public importance and request that ne may make a statement thereon

"The reported precondition laid down by the Bangradesh Govern ment for talks on sharing of Ganga Waters and the salemate ansing out of it"

THE MINISTER OF EXTERNAL AFFAIRS (SHRI YESHWANTRAO CHAVAN) As the House is aware an Agreement was concluded at D cca on 18th April 1975 tetween the Governments of India a i Bangladesh which provided for the operation of the Farakka Barrage and the running of the feeder canal during the lea i season last year penuing further discussions regarding allocat on of the 'eun season flows of the Ganga between the two countries in terms of the Joilt Decla ration of the Prime Ministers of India and Bangladesh of 18th May 1974

In their Deciaration, the two Prime Ministers took note of the fect that the Farakka Barrage Project would be -commissioned before the end of 1974

They recognised that during the perode of minimum flow in the Ganga. there might not be enough water to meet the needs of the Calcutta Port and the full requirements of Bangladesh and, therefore the fair weather flow of the Ganga in the lean months would have to be augmented to meet the requirements of the two count. es was agreed that the problems should be approached with understanding so that the interests of both the countries are reconciled and the difficulties removed in a spirit of friendship and cooperation. It was accordingly decided that the best means of such aug mentation through optimum utilisa tion of the water resources of the region available to the two countries should be studied by the Jont Rivers Commission for making suit_ble recommendations to meet the requirements of both the countries

Talks on sharing of

Ganga waters (CA)

The Government of India have extended an invitation to the Govern ment of Banglidesh to hole talks for the utilisation of he Ganga withis at Farakka during the lean season 50 that a solution consistent with the legitimate needs and interests of the two countries may be found in a spirit of friendship understanding and co operation and on the basis of the Junt Declaration of Wav 1974

The Government of Ind : have drawn attention of the Government of Bangladesh to the fact that , iscussions reparding allocation of the Ganga waters have always been co fined to the lean season from about mi '-March to about mid-May for the obvo ? reason that during the remainder of the year the water flows are plentiful

According to the best lifermation and expert assessment available with the Government of India any withdrawal of the waters of the Gang, in Bangladesh or in India ought not to have any adverse consequences for either country because of the abundance of water throughout the year,
