SHRI JAGANNATH MISHRA (Madhubani): There are more than 25 000 families of weavers in the district of Madhubani, Bihar and their only means of livelihood is weaving.

They are landless and naturally, they are very poor and because of the sky-touching prices of the yarn and other raw materials, they are forced to remain unemployed so much so that they have grown disgusted and annoyed. They have been forced to leave their State and go to Bombay and elsewhere in search of jobs. They are just on the verge of starvation and I would therefore request Government to make a statement so that something concrete or solid is done to ismeliorate their difficulties. Thank you

THE MINISTER OF COMMERCE (PROF. D P CHATTOPADHYAYA): We have already announced on the 9th of February before this honourable House about the policy to alleviate the sufferings and grievances of these persons, which were referred to by the hon Member. In the meanwhile, Sir rules and regulations have been framed and the State Governments also have been suitably instructed to see that the allotted yarn gets lifted up by them and delivered to the weavers concerned. We have, therefore, done our best. Sir, and it is now for the State Governments to do the needful.
