MR SPEAKER : Shri Ramamurti.

Apart from that, under the guise of putting questions, a lot of innuendos, suggestions and all sorts of things, have been made against my Party. I do not want to interfere now. I would request you to give me an opportunity to say what I have got to say so that the matter can be cleared up.
