**STATEMENT REFURTHER DEVELOPMENTS IN NAGALAND**

THE MINISTER OF DEFENCE (SHRI SWARAN SINGH) : rose.

SHRI SWARAN SINGH : I lay it on the Table of the House.

*Statement*

Mr. Speaker Sir, with your permission I wish to make a statement on the latest information available from Nagaland where our Security Forces have been dealing with the gangs of misguided Naga elements who had recently returned from China with arms.

2. The House may recall that in the statement made by me on the 18th March, 1969, in response to a Calling Attention Notice, I had indicated by that Mowu Angami and Loviche Angami and three others from Issac Swu's gang had been captured.

3. Mowu Angami's gang of 170 which had entered Nagaland on the 7th March, 1969 reached the underground PHESAMI Camp, about 80 Kms north east of Kohima, on the 15th March. The Security Forces who had been instructed to apprehend these gangs and take over their weapons located this camp and threw a tight cordon around it. As a result of the pressure exerted by our Security Forces, 165 members of this gang were disarmed and apprehended on the 28th March, 1969. This completes the capture of all members of Mowu Angami's gang of 170. A total of 163 weapons were recovered from this gang. These included four 60 mm mortars, one rocket launcher, eleven 7.62 mm LMGs, 89 semi-automatic rifles, ten .303 rifles, 42 sub-machine guns and 6 pistols. Over and above these, a large quantity of ammunition was also recovered. Bulk of these arms and ammunition are of Chinese origin.

As a result of the action taken by our Security Forces, Issac Swu's gang split into several small groups. These groups are being continuously chased and the area is

being combed to mop them up. So far 82 persons from Issac Swu's gang have been captured and 3 have been killed in 24 encounters and clashes. On our side, there has been only one casualty, namely, 1 officer wounded. Our Security Forces have so far recovered 60 weapons from this gang. These consist of one 60 mm mortar, one rocket launcher, one 7.62 mm LMG, 33 semiautomatic rifles, one 303 rifle, 11 sub-machine guns and 12 pistols. A substantial quantity of ammunition has also been recovered. Most of these weapons and ammunition are of Chinese origin.

Cases against those who have been captured are being examined on merits and appropriate action will be taken against them in accordance with the law.

Our Security Forces have throughout been working in close consultation with the Governor and the Government of Nagaland and receiving full co-operation from the village guards and the civilian population. There have been a number of instances where villagers themselves have rounded up China returned Nagas and handed them over to the Security Forces along with weapons. The Village Guards have also been actively assisting the Security Forces and 9 members of Issac Swu's gang along with weapons were captured by them.

I am sure, the House would wish me to convey our appreciation of the commendable work done by our Security Forces as well as by the Village Guards and the civil population in the Nagaland, and congratulate the Government of Nagaland for the success of these operations. I have no doubt that we have been able to break the backbone of the misguided movement of those Nagas who had sought help and inspiration from foreign Powers. The success of our operations should enable the State Government to bring all the misguided elements to the path of peace and reason, and it is my hope that before long, normalcy would return to Nagaland and all the Nagas would be able to work for their progress and prosperity in accordance with our democratic Constitution and traditions.
