Utilization of Central Assistance gives for Family Planning to Himachai Pradesh

1401. SHRI VIRBHADRA SINGH: Will the Milister of HEALTH AND FAMILY PLANNING be pleased to state:

- (a) whether target of family planning assistance for the rural areas and urban areas for the Fourth Plan has been fully utilised; and
- (b) if so, the amount of Central assistance that has been utilised for the Himachal Pradesh?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND MILY PLANNING (SHRI KONDAJJI BASAPPA): (a) Annual financial assistance to States is not worked out on the basis of rural and urban areas separately but is decided on the basis of various activities to be undertaken under the Family Planning Programme by the concerned States as a whole. The total budget allocation for the Fourth Plan was Rs. 285.76 crores. Nearly 99 per cent of this allocation is expected to be utilised.

(b) The Central assistance utilised by 'Himachal Pradesh during the first four years of the Fourth Plan is Rs. 106.60 lakhs. The allocation for the current financial year is Rs. 18.88 lakhs.
