*364. **SHRI AMRATLAL VALLABHDAS TARWALA:** Will the PRIME MINISTER be pleased to state:

(a) whether the number of members of Kendriya Vidyalaya Sangathan and its Governing Body has been prescribed under the rules;

(b) if so, the details thereof and if not, the reasons therefor;

(c) the details of all the present members of both these organisations; and

(d) the provisions made for employees representation on both these organisations?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI CHIMANBHAI MEHTA): (a) to (c). Yes, Sir. The composition of the Kendriya Vidyalaya Sangathan and its Board of Governors has been prescribed under Rules 3 and 19 of the Rules of the Kendriya Vidyalaya Sangathan. Statement - I and II indicating the relevant rules and the present members of these bodies are attached herewith.

(d) As of now, there are no provisions for representation of employees in these organizations. The Board of Governors of the Kendriya Vidyalaya Sangathan has considered this matter in its meeting of 22.8.90. No conclusive decision has been taken.
