FIFTY-FOURTH REPORT

relegated to an obscure place by putting it between 6 and 7 p. m. when there are hardly any members present here. I would request you to please give it proper time and give it a proper place, and not put it in the way it has been proposed by the Minister.

"Further discussion on the motion regarding Report of the Study Team on Prohibition at 5 P. M. on Thursday, the 10th December, 1970."

It has already been fixed. Why are you worried about it ?
