Shri Nambiar (Tiruchirapalli): On a point of order, Sir. May I know whether this sort of translation will be possible?

Shri H. N. Mukerjee (Calcutta Central): Sir, I did not wish to interrupt you while you were translating the position for the benefit of the hon. Member, but if you are going to make a practice of it, I am afraid, you will have to consider so many other aspects of the situation. You have been insisting, very rightly, that we should economies as far as the time of the House is concerned. If

it is to be the convention or practice by whoever is in the Chair that anything said in English has to be translated in Hindi then surely those hon. Members who do not understand Hindi speeches can insist that any Hindi speech or statement made should at once be translated and the time of the House be consumed in the process. I have no animus against Hindi, but if in this kind of way conventions get going, I do not know where we shall end up.

Mr. Speaker: Our Rules are that any hon, Member can express himself in Hindi or in English. He can use either of the two languages unless there are special circumstances; for example, if an hon. Member does not know either of them we have special provision and the Speaker can allow him to speak in his mother tongue provided a copy of his speech has already been supplied Speaker. That rule will continue. I am not going to spend double time. When an hon. Member speaks in one language I will request other hon. Members to try to understand that themselves or to get the help of their neighbours who are there to know what has been said. I agree with the hon, Member, Shri Mukerjee, that if everyone were to insist like that, it can only be conceived how much time would be spent in such unnecessary things. That is my submission and I hope I will get the cooperation of all the hon. Members. If it is insisted upon, I shall not be able to do that in future.

That healthy practice should be continued and no departure should be allowed to be made.

Mr. Speaker: Did I say something else?

Shri Nambiar: But he is insisting on that point.

Mr. Speaker: Perhaps I could not explain it in so beautiful language.
