Let me take the sense of the House.

Shri Hari Vishnu Kamath (Hoshangabad): I support this move. But, I would only request that sufficient time be allowed for me, at least one minute, so that I can move the Bill standing in my name.

Mr. Chairman: I shall allow time till 5.45 hours. Last time Shri Bhagwat Jha Azad raised a point of order referring to para 2 of what Mr. Mukerjee had spoken. In this, I find that there is no point of order since there is nothing objectionable in what he had stated there. Therefore, Mr. Mukerjee will just continue his speech.

Shri H. N. Mukrejee (Calcutta Central): Mr. Chairman, Sir, as I said last time, it is a pity that the mover has spoken sharply against the Tashkent Declaration and said in his speech that we should act as if it was a dead letter. This kind of a thing is exactly playing in to the hands of those either in Pakistan or elsewhere who wish ill by our country. In spite of some provocations from Pakistani rulers, we should see that nothing is said at a time in responsible circles and in this House, which is certainly a very responsible forum, which goes against the Tashkent spirit. It is a pity that the mover has spoken about the Sadio
