The Council of Scientific and Industrial Research has no regular scheme for specialised training of However, engineers. short specialised training refresher courses in engineering are conducted in some of the National Laboratories Institutes. Such training refresher courses form part of the programme of the Laboratory Institute concerned and no funds are provided for this purpose separately.

CALLING ATTENTION TO MATTER OF URGENT PUBLIC IMPORTANCE

REPORTED DECISION TO WITHDRAW PARTICIPATION OF THE INDIAN CONTIGENT IN THE FORTHCOMING ASIAN
GAMES

Dr. Karni Singhji (Bikaner): Sir, I call the attention of the Minister of

Education to the following matter of urgent public importance and I request that he may make a statement thereon:—

"Reported decision of the All India Council of Sports and Indian Olympic Association to withdraw participation of the Indian contingent in the forthcoming Asian Games."

Shri M. R. Krishna (Peddapalli): Sir before the Minister makes his statement, I want to seek one clarification. I had also sent in a Calling Attention Notice and it was addressed to the Ministry of Finance. The Edu. cation Ministry is as helpless as the Indian Olympic Association or the All India Council of Sports, because the recommendations of the All Council of Sports were accepted by the Ministry of Education and forwarded to the Ministry of Finance. Now, if the Education Ministry is trying to defend the Ministry of Finance it will not be doing any justice.

Mr. Speaker: How can I prevent them from defending anybody?

Shri M. R. Krishna: Sir, don't you see any reason in what I say? My Calling Attention Notice was addressed to the Ministry of Finance.

The Minister of Information and Broadcasting (Shri Raj Bahadur): Of course, Sir, the Ministry of Education was in sympathy with the recommendations of the All India Council of Sports. Nevertheless, it was the Speaker who ruled that the Ministry of Education should answer the Calling Attention Notce (Interruptions).

Shri M. R. Krishna: Sir, it is not that I am talking something trash. Please listen to me.

Mr. Speaker: I have listened to him. His name is included here. What more does he want?

Shri M. R. Krishna: Sir, the Ministry of Education has already recommended the contingent to the Minis-

try of Finance. It is the Ministry of Finance which has brought it down. Therefore, it should be the Ministry of Finance which should answer this and from that we will be able to know whether the Finance Ministry is right or wrong.

Mr. Speaker: Let me proceed. Let us hear what the Minister has to say.

Shri S. M. Banerjee (Kanpur): Sir, you have read the statement. The statement is here.

The Deputy 'Minister in the Ministry of Education (Shri Bhakt Darshan): Sir, before I read the statement, I want to seek your permission to make some slight correction in the statement already circulated. The 5th Asian Games are scheduled to be held in Bangkok from December 9 to 20, 1966. In this connection, the Indian Olympic Association which is responsible for sponsoring Indian Contingents for participation in international games, had originally proposed a contingent of 151 persons to be sent proposal to Bangkok, Their considered by the All India Council of Sports which advises the Ministry of Education in all matters concerning games and sports, in September, 1966 and the Council advised the Indian Olympic Association to bring down the number of players and officials to about 80-100, nearer 80 than 100, to save expenditure in rupees and foreign exchange.

The Indian Olympic Association even in their revised proposals recommended a contingent of 135 persons. After that the Standing Committee of the All India Council of Sports, after discussing the matter with the office-bearers of the Indian Olympic Association, recommended a contingent of 117 persons. Subequently, as a result of further discussions held between the President, Indian Olympic Association, President, All India Council of Sports and the Ministry of Education, the size of the contingent was further reduced to 105, including players, officials, delegates etc.

[Shri Bhakt Darshan]

That final proposal was very carefully examined from foreign exchange angle in the Ministry of Finance and it was found that the Government would not be in a position to release foreign exchange for more than 81 persons. The President, Indian Olympic Association was therefore, informed of this decision and was requested to restrict the size of the contingent to 81 persons. However, it seems that the Indian Olympic Association is not prepared to accept the reduced size of the contingent and so they have announced withdrawal of India's participation from these games.

The Ministry of Education has tried its level best to prevail upon the Indian Olympic Association to accept the reduced size of the contingent, keeping in view our foreign exchange difficulties; but the Indian Olympic Association does not see its way in accepting this suggestion.

India's non-participation in this year's Asian Games, will no doubt cause disappointment to the sportsnen in the country and to the sportsloving community in India, Thailand and other countries; but keeping in view our foreign exchange limitations, we cannot afford to provide for a contingent of more than 81 persons.

The Government's offer to send a contingent of 81 persons is still open. We would therefore, once again appeal to the Indian Olympic Association to accept it in the true spirit of sportsmen.

Dr. Karni Singhji: May I know if the Government realises the immense loss of India's prestige in the international sports world if we were not to enter the Asian Games, India being the originator of the games and when the first of the series were held in Delhi, and the reason for Government's rigid attitude not to consider the Olympic Association's suggestion to include a contingent of 105 sportsmen representing the cream of India's youth, thereby disappointing not only

the contestants but also millions of other sports-loving citizens of India, the extra foreign exchange requirement being a patry sum of £1,000, when more than such sums are wasted on non-essential delegations?

Shri Raj Bahadur: We are in entire sympathy and even in accord with the sentiments expressed by the hon. Member. But may I submit for the consideration of the House that last time when this country participated in the Asian Games in Jakarta four years ago the total complement allowed was 81, which was willingly accepted. Because of our foreign exchange difficulties we thought that this time also we could retain the old figure of 81. That was the reason which largely weighed with Government in sanctioning that number.

Shri Shivaji Rao S. Deshmukh (Parbhani): Is there birth control in the sports world also so that there could be no increase from 81 to 105 within four years?

श्री यशपाल सिंह (कैशना): जिसे यह ये कल्वरल प्रोगराम कहते हैं, साल भर में उन पर करोड़ों रुपया खर्च होता है और उन के बारे में कोई आरैन एक्सचेंज की डिफ़ी-कल्टी सामने नहीं आती है। इस तरह की हरकतों से खुद सरकार का किर नीचा होता है और विदेशों में हभारी निष्प्रभता सिद्ध होती है। क्या सरकार ने यह सोचा है कि कि इस सम्बन्ध में फ़ारैन एक्सचेंज की जो दिक्कत है, उस को फ़ौरन दूर किया जाये? क्या सरकार ने इस बात पर भी और किया है कि फ़ारैन एक्सचेंज देने का आफ़िस और सेवणनिंग एथारिटी एक होनी चाहिये, अलग अलग नहीं होना चाहिए?

श्री राज बहाबुर: माननीय सदस्य काफ़ी विद्वान हैं श्रीर वह जानते हैं कि "कतरा कतरा शवद दिखामें " हम बून्द बून्द बचा कर ही फ़ारेन एकसचेंज को बचाने की कोशिश करते

हैं। मैं उन को यकीन दिलाना चाहता हूं कि अभी भी इस बात की कोणिश की जा जा रही है कि किस तरह इस मुशिकल को हल किया जाये।

Shri M. R. Krishna: This youthful Government, which is spending a lot of money on student discipline and understands the importance of international understanding and co-operation, why it has not thought it fit to encourage sportsmen and sports by allowing that contingent to go to an Asian country and participate in the Asian games to develop international understanding?

Shri Raj Bahadur: There is not the slightest difference of opinion about the objective to be achieved. We extremely regret that our country may not be in a position to participate in the Games. But we still hope that perhaps with some persuasion, some discussion and some adjustment it may be possible for them to participate,

Mr. Speaker: Shri S. M. Banerjee.

Shri M. R. Krishna: Sir, I want to ask one more question.

Mr. Speaker: I am sorry, only one question is allowed.

Shri M. R. Krishna: If I had known that, I would have asked the other question. I may be permitted to ask one more question,

Mr. Speaker: I am sorry.

Shri S. M. Banerjee: It is mentioned in the statement:

"The Government's offer to send a contingent of 81 persons is still open. I would, therefore, once again appeal to the Indian Olympic Association to accept it in the true spirit of sportsmen."

I want to know whether the hon. Minister is aware that in 1964 or 1965 the businessmen of the country who wanted to go abroad were given foreign exchange to the tune of Rs 2.85 crores for merely visiting and sight-seeing. In view of that,

may I know whether they will try to improve the number from 81 because the number of athletes has also increased during the last four years? Will they reconsider the whole matter and see that the contingent goes there to keep the good name of India?

Shri Raj Bahadur: I am not at all aware of the astronomical figure of Rs. 2 crores-and-so-many-lakhs,

Shri S. M. Banerjee: The Finance Minister made the statement here in this House.

Shri Raj Bahadur: It is not a sin not to be aware. I do not know. But I do not also know what is the relevance between the two. I think, this matter has to be decided on its own merits.

Shri S. M. Banerjee: For a businessman you will give everything.

Shri Joachim Alva (Kanara): While warmly commending the Finance Minister in permitting such a large number of 80 persons to go abroad when we have got this grave financial difficulty, may I know what power the Government of India possesses in controlling a body like the Olympic Association which in the name of India is preventing 80 persons representing us abroad and depriving the founder country like India of representing us in the Games and what steps Government has taken to put a ten-year programme of sports like hockey, ricket, football, volleyball etc., so that the reactionary forces of maharajas and super-maharajas-with apologies to Maharaja Karni Singhji-and officials may be cut off? A Deputy Secretary, who is a PRC and who is going, is also cut off. There is an unholy alliance of these forces.

Shri Raj Bahadur: I am sure that the House will agree with me that on the national plane every element in the society, maharajas included, should be free to participate. Therefore, we cannot really say that this committee or that committee is not good. I would say that our team is constituted

of some of the best sportsmen and we have got to give them the fullest recognotion and appreciation for that. We should try to adjust the differences as far as possible and we will try to persuade them as best as we can.

Shri Nambiar (Tiruchirapalli): We have only two more days,

Shri Nambiar: Will you persuade the Minister to accept it tomorrow?
