Air Hot line arrangement with Jaslok Hospital regarding the health of Shri Jayprakash Narayan

(a) whether All India Radio is having a Hot line or similar arrangements with Jaslok Hospital to obtain information regarding health of Shri Jayprakash Narayan;

(b) whether after incorrect announcement made in Lok Sabha regarding J.P.'s death the Bombay correspondent of All India Radio quoted doctors as saying that JP was alive at 1.50 P.M. and promptly this correct portion was carried by the Urdu news bulletin which was already on the air and thereafter the English news bulletin at 2 P.M.; and

(c) what regard has been given to the AIR's newsmen responsible for the occasion to give a correct news and to rehash the bulletins within minutes?

Appointment in Bongaigaon Refineries

10750. SHRI AHMED HUSSAIN: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) cadre-wise number of posts so far filled by the Bongaigaon Refineries and Petrochemicals Ltd. (BRPL) and amount of deputation/duty allowance paid to each cadre (since inception of

the office at Bongaigaon) and cadre-wise reasons as to why recruitment has been made on deputation basis;

(b) whether persons employed by the BRPL at New Delhi Office (before shifting to the project site) on transfer to the project site are being given deputation/duty allowance to compensate their unwillingness to serve in places other than Delhi;

(c) if so, whether Government have kept all the applications/application forms preserved to ascertain whether suitable persons are available or not at the time of recruitment to various posts and if not the reasons therefor; and

(d) why some clerical posts are being filled/proposed to be filled up on deputation basis and not from the Local Employment Exchange or press advertisements?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) The cadrewise number of posts so far filled by the Bongaigaon Refinery and Petrochemicals Limited on deputation basis is attached.

The reasons for taking people on deputation to various cadres are the need for having personnel with requisite experience or non availability of suitably qualified personnel by direct recruitment or the requirement of certain categories of personnel only for a limited period of time.

The amount of deputation allowance paid to deputationists during the past five years is as follows:—
