Shrimati Ila Palchoudhuri: (Nabadwip): So have I.

Shrimati Ila Palchoudhuri: I want to continue. I am thankful to you, Sir, that you have also thought it necessary that a who's who of people who participated in the freedom movement should be complied. I am very grateful for your support to that and I hope that it will be done. A list of the people who went to the Andamans should also be made. As I was saying, yesterday he cellularjail is being demolished and there is only one blackboard with a names. It is not even complete; it does not give all the names of fighters who participated in the freedom movement. When I saw. Commissioner in the Andamans he also said that he would be glad to have a complete list so that he could put it up there for all the future generations to see who the people were who participated in the freedom movement and suffered in jail in the Andamans. for the cause of India's freedom. I would also like to bring certain matters about the films to the notice of the House. Much has been said and there has been a lot of criticism about the film censor board and it was made to appear as if they were doing nothing and that they did not censor all the bad films. But the actual difficulty lies not with the film censor board not doing their work but it is the Cinematograph Act that binds them. They cannot censor things which do not fall within the purview

recommendation of the President. •Moved with the
