been located at Hirakud, the headquarters of the Circle and for the same reason, the Northern Irrigation Division, which is a Division under the Hirakud Dam Circle, has been located at Burla, the headquarters of the Circle.

On receipt of subsequent information from the Government of Orissa it is found that the Medical College Building Division has been located at Hirakud due to want of accommodation at Burla. The Northern Irrigation Division was shifted from Hirakud to Burla on 26th April, 1960. The Medical College Building Division, which was created in May, 1960, was proposed to be located at Burla but as there was no accommodation available there, the Division was located at Hirakud.
